CIRCULAR

Departmental Examination for Auditors – March 2022

- Departmental Examination for Auditors is likely to be held in March 2022. Therefore, interested
 and willing officials belonging to the following categories may submit their applications in the
 prescribed format *(enclosed)* through their respective reporting officers after due verification
 with Service Book to Confidential Cell latest by <u>28/02/2022</u>:
 - (i) <u>Directly recruited Auditors with 1 year's continuous service</u>: They are required to pass the departmental examination for confirmation and promotion to the higher scale of Senior Auditors.
 - (ii) <u>Clerks promoted as Auditors on seniority basis</u>: They are required to pass the departmental exam for promotion to the higher scale of Senior Auditors.
 - (iii) <u>Graduate Group 'C' officials with combined regular service of 3 years as on 04/02/2022</u>: They have to pass the departmental examination to be eligible for promotion to the post of Auditor under '*examination*' quota in terms of Headquarters Circular No. 06-Staff (App 1)/2022 issued under letter No. 158-Staff (App-1)/18-2020 dated 04/02/2022.
- 2. Directly recruited Auditors and graduate Clerks/MTS having deficiency in qualifying service up to a maximum of 2 months as on **01/02/2022** may also appear in the aforesaid Examination subject to the condition that their deficiency in qualifying service is condoned by the Principal Accountant General in terms of Para 9.4.4 of MSO (Admn) Vol-I.
- 3. In terms of Examination Wing Circular No. 01 of 2022 issued under letter no. 04/08-Exam/Syllabus Revision/2021 dated 06/01/2022, the Departmental Examination for Auditors will be conducted on 'Multiple Choice Questions (MCQ)' pattern except wherever there is testing of language skill in English/Hindi/Other Indian language, the existing pattern of descriptive mode shall be continued.

Further, in terms of Examination Wing Circular No. 02 of 2022 issued under letter no. 05/08-Exam/Syllabus Revision/2021 dated 07/01/2022, the syllabus of the Departmental Examination for Auditors has been revised and a paper on 'Information Technology Practical' has been introduced. The question papers on the revised syllabus will be in MCQ pattern (except IT Practical). The IT Practical paper will be computer based.
