विषय: राज्यं सरकार के कर्मियों को अपुनरीक्षित वेतनमान (पंचंम वेतनमान) में दिनांक 01.01.2019 के प्रभाव से महँगाई भत्ता की दरों में अभिवृद्धि के संबंध में।

वित्त विभाग के संकल्प संख्या 660 / वि•, दिनांक 28.02.2009 के द्वारा राज्य सरकार के सेवीवर्ग को दिनांक 01.01.2006 के प्रभाव से छठा केन्द्रीय पुनरीक्षित वेतनमान / वेतन संरचना की स्वीकृति प्रदान की गयी है। वित्त विभागीय संकल्प 217 / वि॰ दिनांक 18.01.2017 के द्वारा राज्य कर्मियों को सप्तम् वेतन पुनरीक्षण का लाभ दिया गया है।

- 2. भारत सरकार के वित्त मंत्रालय, व्यय विभाग के कार्यालय ज्ञापन संख्या 1/3/2008-E.II(B), दिनांक 08.03.2019 के द्वारा केन्द्र सरकार एवं केन्द्रीय स्वशासी निकाय के वैसे कर्मी, जो अपुनरीक्षित पंचम वेतनमान में वेतन प्राप्त कर रहे हैं, के लिए दिनांक 01.01.2019 के प्रभाव से महँगाई भृते की दर 295% (दो सौ पनचानवें प्रतिशत) कर दी गयी है।
- 3. उपर्युक्त पृष्ठभूमि में राज्य के वैसे संवर्ग / कर्मी, जो अपुनरीक्षित पंचम वेतनमान में वेतन प्राप्त कर रहे हैं, के संबंध में निर्णय लिया गया है कि उन्हें केन्द्र के अनुरूप दिनांक 01.01.2019 से महँगाई भत्ता की दर 284% (दो सौ चौरासी प्रतिशत) से अभिवृद्धि करते हुए 295% (दो सौ पनचानवें प्रतिशत) स्वीकृत किया जाय।
- 4. झारखंड सेवा संहिता के परिभाषा नियम 34(ए) के अनुसार मूल वेतन पर महँगाई भत्ता देय है, परन्तु विशेष/वैयक्तिक वेतन पर यह देय नहीं होगा।
- 5. प्रस्ताव पर मंत्रिपरिषद् की स्वीकृति वित्त विभागीय संलेख ज्ञापांक 2154 / वि० दिनांक 13.08.2019 के क्रम में दिनांक 14.08.2019 की बैठक के मद सं० 11 में दी गई है।

RESOLUTION

Sub: Enhancement in the rates of Dearness Allowance to the employees of State Government in unrevised pay scale (Fifth Pay Scale) w.e.f. 01.01.2019 – reg.

Vide Department of Finance, Resolution No. 660/Fin. dated 28.02.2009, sanction has been accorded for Sixth Central Revised Pay Scale/Pay Structure w.e.f. 01.01.2006 to the employees of State Government. Vide Department of Finance, Resolution No. 217/Fin. dated 18.01.2017, benefits of Seventh Pay Revision have been given to State employees.

- 2. Vide Government of India, Ministry of Finance, Department of Expenditure, OM No.1/3/2008-E(II)(B), dated 08.03.2019, the rate of dearness allowance of those employees of the Central Government and Central Autonomous Bodies who are receiving pay in the unrevised Fifth Pay Scale has been fixed at 295% (Two Hundred Ninety Five Percent) w.e.f. 01.01.2019.
- 3. In the above context, with regard to those cadre/employees of State, who are receiving pay in the unrevised Fifth Pay Scale, it has been decided that sanction may be given to increase the rate of their dearness allowance from 284% (Two Hundred Eighty Four Percent) to 295% (Two Hundred Ninety Five Percent) w.e.f. from 01.01.2019, in conformity with central government.
- 4. As per Rule 34 (a) of Jharkhand Service Code, dearness allowance is payable on basic pay, but shall not be payable on special/personal pay.
- 5. Sanction of the Council of Ministers on the proposal is given in item no.11 of the meeting of 14.08.2019 in continuation to Department of Finance, Document Memo No. 2154/Fin. dated 13.08.2019.
- ORDER: Ordered that this resolution be published in the extra ordinary edition of the Gazette of Jharkhand and its copies be forwarded to all Departments/Heads of Departments and the Accountant General (A&E), Jharkhand, Ranchi.
