
Subject:- Revision of Pension of pre-01.01.2016 State Pensioners/
Family Pensioners.

In partial modification of Finance Department Memorandum of even number dated 30-10-2017 as amended vide Finance Department Memorandum of even number dated 05-12-2017 and 09-12-2017 under which the Pension Disbursing Bank of the pensioner/ family pensioner was authorised to revise the pension / family pension (including consolidated pension/ family pension) by multiplier of 2.57 and rounded off to next rupee with effect from 01-01-2016.

2 The matter has been considered further and the Governor is pleased to order that the Pension Disbursing Bank of the pensioner/ family pensioner shall revise the pension / family pension without waiting formal request by the pensioner / family pensioner and surrendering of half of Pension Payment Order portion and shall make payment of the revised pension as specified in para 15 and 16 of Finance Department Memorandum of even number dated 09-12-2017.

3 As and when the half of Pension Payment Order portion is surrender to the Pension Disbursing Bank by the pensioner/ family pensioner, the entry regarding revised pension/ family pension w.e.f. 01-01-2016 shall be made on half of the Pension Payment Order portion and it shall returned to pensioner/ family pensioner, as the case may be.
