

विषय : दिनांक 01.01.2016 से पुनरीक्षित/प्रभावी राज्य सरकार के पेंशन/पारिवारिक पेंशनभोगियों को 01 जुलाई, 2019 के प्रभाव से महंगाई राहत की दरों में अभिवृद्धि के संबंध में।

केन्द्र सरकार के द्वारा सप्तम वेतन पुनरीक्षण के फलस्वरूप अपने पेंशनधारियों/पारिवारिक पेंशनभोगियों को दिनांक 01.01.2016 के प्रभाव से स्वीकृत पेंशन पुनरीक्षण के अनुरूप राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों को योजना-सह-वित्त विभागीय संकल्प संख्या 218/वि. दिनांक 18.01.2017 द्वारा पेंशन पुनरीक्षण अनुमान्य किया गया है। उक्त संकल्प की कंडिका- 9.1 में केन्द्र सरकार के अनुरूप महंगाई राहत अनुमान्य किया गया है।

2. भारत सरकार के लोक शिकायत एवं पेंशन मंत्रालय के पत्र संख्या 42/04/2019-P&PW(D) दिनांक 21.10.2019 के द्वारा केन्द्र सरकार के पेंशन/पारिवारिक पेंशनभोगियों को पुनरीक्षित वेतनमान/वेतन संरचना (सातवें वेतनमान) में दिनांक 01.07.2019 के प्रभाव से महंगाई राहत की वर्तमान दर को 12% (बारह प्रतिशत) से बढ़ाकर 17% (सतरह प्रतिशत) करने का निर्णय लिया गया है।

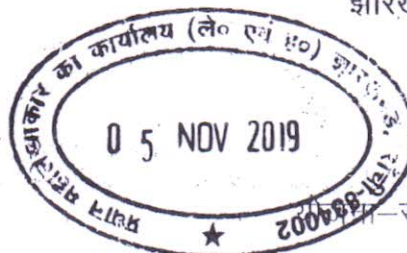
3. उपर्युक्त पृष्ठभूमि में केन्द्र के अनुरूप राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों को वर्तमान में अनुमान्य महंगाई राहत की दर को सम्यक विचारोपरान्त निम्नरूपेण संशोधित करने का निर्णय लिया गया है :-

“राज्य के पेंशनधारियों/पारिवारिक पेंशनभोगियों, जिनके मूल पेंशन का पुनरीक्षण (सप्तम वेतन पुनरीक्षण) वित्त विभाग के संकल्प संख्या 218/वि. दिनांक 18.01.2017 द्वारा दिनांक 01.01.2016 के प्रभाव से किया गया है, उन्हें दिनांक 01.07.2019 के प्रभाव से मूल पेंशन का 17% (सतरह प्रतिशत) महंगाई राहत स्वीकृत किया जायेगा”।

4. प्रस्ताव पर मंत्रिपरिषद् की स्वीकृति वित्त विभागीय संलेख ज्ञापांक 2866/वि० दिनांक 25.10.2019 के क्रम में दिनांक 25.10.2019 की बैठक के मद सं० 22 में दी गई है।

RESOLUTION

Sub : Enhancement in the rates of Dearness Relief w.e.f. 1st July 2019 to the Pensioners/ Family Pensioners of the state Government, revised/effective from 01.01.2016 – reg.

Vide Planning-Cum-Finance Department, Resolution No. 218/Fin. dated 18.01.2017, Pay Revision has been permitted to the Pensioners/Family Pensioners of the State Government in accordance with the pension revision sanctioned w.e.f. 01.01.2016 by the Central Government to their Pensioners/Family Pensioners. In para 9.1 of the above Resolution, Dearness Relief has been sanctioned in accordance with the Central Government.

2. Vide Ministry of Personnel, Public Grievances and Pension, Government of India Letter No. 42/04/2019-P&PW(D) dated 21.10.2019, it has been decided to increase the present rate of dearness relief to the Central Government pensioners/family pensioners, from 12% (Twelve Percent) to 17% (Seventeen Percent) w.e.f. 01.07.2019, in the revised pay scale/pay structure (Seventh Pay Scale).

3. In the above context, after due consideration it has been decided to revise the rate of dearness relief permissible at present to the Pensioners/Family Pensioners of the State Government in accordance with the Central Government, as below :-

“Dearness Relief of 17% of basic pension shall be sanctioned w.e.f. 01.07.2019 to those pensioners/family pensioners of the State Government, whose basic pension has been revised (Seventh Pay Revision) w.e.f. 01.01.2016 vide Resolution No. 218/Fin. dated 18.01.2017 of the Department of Finance.

4. Sanction of the Council of Ministers on the proposal is given in item no. 22 of the meeting of 25.10.2019 in continuation to Document Memo No.2866/Fin. dated 25.10.2019 of the Department of Finance

Order : It is ordered that this resolution be published in the extra ordinary edition of the Gazette of Jharkhand and its copies be forwarded to all Treasuries/ Sub Treasuries and the Accountant General (A&E), Jharkhand, Ranchi.
