Sub: Grant of Dearness Relief to Pensioners and Family Pensioners of Union Territory of Puducherry – Revised rates effective from 01/07/2019 – Reg.

The Government of India have revised the rate of Dearness Relief on Pension / Family Pension with effect from 01/07/1019 at the rate of 17% in O.M.No.42/04/2019-P&PW(D), dated 21/10/2019 of the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners' Welfare, New Delhi.

- The Government of Puducherry has communicated the Orders of Government of India for extending the revised rate of Dearness Relief @ 17% with effect from 01/07/2019 to the Pensioners / Family Pensioners of the Union Territory of Puducherry vide G.O. Ms. No.182/FD/F3/ A2/2019, dated 05/11/2019 of the Finance Department, Puducherry.
- On the basis of the above orders, I am to authorize to effect payment of Dearness Relief at the 3. revised rate of 17% as mentioned above with effect from 01/07/2019 to all eligible Pensioners / Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks / Treasuries / Sub-Treasuries under your control subject to conditions governing the payment of Dearness Relief on Pension / Family Pension as detailed in the Government of India Office Memorandum aforesaid.
