

(5) Orders of the Hon. Supreme Court passed on 27.03.2015 in the Writ Petition No.643 \2015

Preamble:- In accordance to the directions of the Hon. Supreme Court for study of Pay Scales and Allowances and the Pensions and other benefits after retirement and other related issues of the Judicial Officers of the Central and the State Governments and the Centrally Administered States the Pay Scales and Allowances and the Pensions and other benefits after retirement has established a Second National Pay Commission. The Second National Pay Commission (Hon. Justice Reddy Commission) on 09.03.2018 has submitted Interim Pay Report to the Hon. the Supreme Court..

The Hon. Supreme Court passed orders on 27.03.2018 in the Writ Petition No.643 \2015 appointed the Second National Pay Commission, this Pay Commission has submitted Interim Recommendations for the Judicial Officers\Pension and the Family Pension Holders and passed orders that these recommendations to be made applicable to the Judicial Officers in the State and has given directions to the State Government to make it applicable. Further the Hon..the Supreme Court has passed the orders that in the Basic Pay of the Judicial Officers 30% pay hike should be given from 01.05.2018 and regard to the arrears it should be paid up to 30.06.2018. The issue to make the Interim recommendation of the Second Pay Commission applicable to the Subordinate Judges in the State was under consideration of the Government.

Government Resolution:- In Accordance to orders passed by the Hon. Supreme Court on 27.03.2018, the Interim Recommendations of the Second Pay Commission are hereby made applicable to the Subordinate Judicial

Officers, Pension Holder Judicial Subordinate Officers and the Family Pension Holders from 01.01.2016 as below:-

- 1) All the Subordinate Judicial Officers in all the cadres of Subordinate Courts in the State in the Basic Pay of the Judicial Officers 30% pay hike should be given and implemented from 01.05.2018.
- 2) This increase in the pay should be treated as separate component and on this Dearness Allowance will not be applicable on this Pay Increase.
- 3) The amount of the arrears will be paid as below:-

(1) In case of the Judicial Officers whose Provident Fund Account is in existence as on 01.05.2018 they will be paid 60% amount in cash and the 40% amount will be credited in their Provident Fund Account.


(b) In case of the Judicial Officers whose Provident Fund Account is not in existence as on 01.05,2018 they will be paid the amount of the arrears in cash.

4) The interim relief shall be given to the pensioners and family pensioners, on the same basis as given to the serving Judicial Officers, with effect from 01.01.2016 and the arrears be paid to them in cash by 30.06.2016.

5) After interim Pay Fixation and after the final report of the pay fixation the payable amount will be adjusted.

2. The expenditure to be incurred in this regard will be met from sanctioned grant of the year






