
OFFICE MEMORANDUM

Sub:- Revision of Pension/ Family Pension of Pre-2016 and Post-2016 Pensioners/Family Pensioners (for Teachers and equivalent cadres of Odisha University of Agriculture & Technology) under UGC Scale of Pay.

In pursuance of this Department Resolution No.22046 dated 22.11.2019 as well as Finance Department O.M. No.28300/F dated 23.09.2017, State Government have been pleased to revise the Pension/ Family Pension/Gratuity / CVP for Pre-2016 and Post-2016 for Post-2016 pensioners (for Teachers and equivalent cadres of Odisha University of Agriculture & Technology) w.e.f. 01.01.2016 in the manner indicated in the subsequent paragraphs.

2. These orders shall apply to all Pre-2016 Pensioners/ Family Pensioners who were drawing pension/ family pension on 31.12.2015 and post-2016 pensioners/ family pensioners under the Odisha Civil Services (Pension) Rules, 1992 with UGC Scale of Pay.
3. In these orders
- (a) "Existing Pensioner" or "existing Family Pensioner" means a pensioner/ family pensioner who was drawing/ entitled to pension/ family pension on 31.12.2015.
- (b) "Existing Pension" means the basic pension including the commuted portion, if any, due on 31.12.2015. It covers all classes of pension under the Services of OUAT.
- (c) "Existing family pension" means the basic family pension as drawn on 31.12.2015 under the Services of OUAT.
4. The Pension/ Family Pension of existing Pre-2016 Pensioners/ Family Pensioners shall be consolidated with effect from 01.01.2016 by following manner:-
- 4.1 The existing Pension and Family Pension of all Pre-2016 Pensioner/ Family Pensioner as on 01.01.2016 shall be revised by multiplying a factor of 2.57. The amount of revised pension/ family pension so arrived at shall be rounded off to next higher rupee.

- 4.2 For this purpose the existing pension/ family pension shall be the basic pension/ family pension only without the element of additional pension available to the pensioners/ family pensioners of the age of 80 years and above.

Provided that the revised full pension of all Pre-2016 Pensioners relatable to maximum period of qualifying Service i.e. 25 years shall in no case be less than the 50% of the 1st Cell of the replacement level in Pay Matrix shown in **Annexure 'A'** w.e.f. 01.01.2016 as notified by this Department.

- 4.3 In case of pensioners who are in receipt of more than one pension, the floor ceiling of Rs.8,300/- shall apply to the total of all pensions taken together.
- 4.4 The basic pension/ family pension as worked out in accordance with the provisions of Para-4 above shall be treated as final basic pension w.e.f. 01.01.2016 for the purpose of sanction of dearness relief to be sanctioned thereafter.
- 4.5 The revised family pension of all pre-2016 family pensioners shall not be less than 30% of the 1st Cell of the replacement level in Pay Matrix of the scale of pay of the post last held by the pensioner at the time of his/her retirement/death shown in Annexure 'A' w.e.f. 01.01.2016 as notified by this Department vide No. 4434/A&FE, dated 26.02.2020.
- 4.6 Since the basic pension shall be inclusive of commuted portion of pension, the commuted portion if availed by the pensioner shall be deducted from the said amount while making monthly disbursements. Besides, the ex-gratia relief granted in Finance Department OM No.56932/F., dated 28th November, 1986 shall also be paid in addition to the consolidated pension in respect of eligible pensioners.
- 4.7 The minimum pension/ family pension in no case shall be less than Rs.8,300/- per month with effect from 01.01.2016. The upper ceiling on pension and family pension shall be 50% and 30% respectively of the highest pay in the Government under UGC scale. The minimum and the maximum limit shall exclude the element of additional pension.
- 4.8 The quantum of additional pension/ family pension available to the pensioners/ family pensioners shall be revised to the percentage of basic pension/ family pension as per the table below w.e.f. 01.01.2016.



Age of Pensioners /family Pensioner	Additional quantum of Pension
From 80 years to less than 85 years (completion of 80 years)	20% of revised basic pension/ family pension
From 85 years to less than 90 years (completion of 85 years)	30% of revised basic pension/ family pension
From 90 years to less than 95 years(completion of 90 years)	40% of revised basic pension/ family pension
From 95 years to less than 100 years (completion of 95 years)	50% of revised basic pension/ family pension
100 years or more (completion of 100 years)	100% of revised basic pension/family pension

4.9 Pension disbursing Authorities including Public Sector Banks handling disbursement of Pension/ Family Pension to the Pensioners/ Family Pensioners of OUAT are hereby authorised to pay Pension/ Family Pension to the existing Pensioners/ Family Pensioners by multiplying a factor of 2.57 to the existing Basic Pension/ Family Pension and rounding off the same to next higher rupee at first instance. It will be enhanced further with Additional Pension, if any. Such revision in respect of Pre-2016 pensioners will take effect from 01.01.2016 and in case of post-2016 pensioners from the date of first drawal of pension.

4.10 The pre-2016 Pensioners/ Family Pensioners shall submit an application to the Comptroller of Finance, OUAT, Bhubaneswar in the form as at **Annexure 'B'**.

4.11 The fact of authorization of the revised rate of Pension/ Family Pension shall be recorded in both halves of Pension Payment Order (PPO) under the dated signature of the Comptroller of Finance, OUAT/ authorised officer of Public Sector Banks as the case may be, in both the cases while revising the Pension/ Family Pension.

4.12 The Pension Disbursing Authorities shall intimate the concerned Public Sector Banks regarding the revision of pension/ family pension in Form as at **Annexure -C**.

5. Revision of Pension/ Family Pension of Post-2016 Pensioners/ Family Pensioners.

5.1 PENSION

The revised provisions as per these orders shall apply to Teachers and equivalent cadres of Odisha University of Agriculture and Technology who retire/ die in harness on or after 1.1.2016 and are drawing/ entitled to draw their pension/ family pension as per the existing principle adopted by the Universities.

5.2 Where pension/ family pension/ Gratuity/ Commutation value of pension, etc. has already been sanctioned in pre-revised scale of pay on or after 1.1.2016, the same shall be revised in terms of these orders. In cases where pension has been finally sanctioned on the pre-revised orders and if it happens to be more beneficial than the pension becoming due under these orders, the pension already sanctioned shall not be revised to the disadvantage of the pensioner.

5.3 EMOLUMENTS

The term 'Emoluments' for purposes of calculating various pensionary benefits other than different kinds of Gratuity shall have the same meaning as in Rule 2 (e) of the Odisha Civil Services (Pension) Rules, 1992.

5.4 Basic pay in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix only with effect from 01.01.2016 and does not include any other type of pay like special pay, etc.


5.5 Emoluments for the purpose of all kinds of Gratuity shall include Dearness Allowance admissible on the date of retirement/ death of the employee.

5.6. Subject to Para 5.7, there shall be no change in the provisions regulating the amount of pension as contained in Rule 47 of the OCS (Pension) Rules, 1992.

5.7 The amount of pension shall be subject to a minimum of Rs.8,300/- and the maximum pension would be 50% of highest pay in the Government.

5.8 The quantum of additional pension/ family pension available to the old pensioners/ family pensioners shall continue to be as follows:-

Age of Pensioners / family pensioner	Additional quantum of Pension
From 80 years to less than 85 years (completion of 80 years)	20% of revised basic pension
From 85 years to less than 90 years (completion of 85 years)	30% of revised basic pension
From 90 years to less than 95 years (completion of 90 years)	40% of revised basic pension
From 95 years to less than 100 years (completion of 95 years)	50% of the revised basic pension
100 years or more (completion of 100 years)	100% of revised basic pension



The Pension Sanctioning Authorities should ensure that the date of birth and the age of a pensioner/ family pensioner is invariably indicated in the pension payment order to facilitate payment of additional pension by the Pension Disbursing Authority as soon as it becomes due. The amount of additional pension shall be shown distinctly in the pension payment order. For example, in case where a pensioner is more than 80 years of age and his pension is Rs.10,000 p.m., the pension shall be shown as (i) Basic pension=Rs.10,000 and (ii) Additional pension = Rs.2,000 p.m. The pension on his attaining the age of 85 years shall be shown as (i) Basic Pension= Rs.10,000 and (ii) additional pension = Rs.3,000 p.m.

6. FAMILY PENSION

- 6.1 Family pension shall be calculated at a uniform rate of 30% of basic pay in the revised pay structure. This shall be subject to a minimum of Rs.8300/- p.m. and maximum of 30% of the highest pay in the Government as per UGC scale of Pay.
- 6.2 The amount of enhanced family pension shall be 50% of basic pay in the revised pay structure and shall be subject to a minimum of Rs.8300 p.m. and maximum of 50% of the highest pay in the in the revised pay structure.
- 6.3 Apart from above the other provisions shall be guided by the Circulars issued by the Government in Finance Department from time to time.

7. Dearness Relief (TI)

The pension/ family pension under Para 5 and 6 above shall qualify for dearness relief sanctioned from time to time.

8. Retirement/ Death Gratuity

- 8.1 The rates for payment of death gratuity shall be revised as under.

Length of qualifying service	Rate of Death Gratuity
Less than One year	2 times of monthly emoluments
One Year or more but less than 5 years	6 times of monthly emoluments
5 Years or more but less than 11 years	12 times of monthly emoluments
11 Years or more but less than 20 years	20 times of monthly emoluments
20 Years or more	Half month's emoluments for every completed six monthly period of qualifying service subject to a maximum of 33 times of emoluments

8.2 The maximum limit of Retirement gratuity and death gratuity shall be Rs.15 lakh (Rupees fifteen lakh) only.

9. Commutation of Pension.

There shall be no change in the provisions relating to commutation values, the limit up to which the pension can be commuted or the period after which the commuted pension is to be restored. On account of revision of pay/ pension w.e.f. 01.01.2016, the post-2016 pensioners shall be entitled for differential amount of commuted value of the pension as per the provisions laid down under the F.D. Resolution No. 28300/F., dated 23.09.2017.

10. Payment of arrears.


In case of Teachers and equivalent cadres of Odisha University of Agriculture & Technology who have already retired from service between 01.01.2016 to the date of publication of this Office Memorandum, the entire arrears salary and pension may be drawn and disbursed in one installment after cross verification of pay fixation statement by the authority. The Teachers and equivalent cadres of Odisha University of Agriculture & Technology retiring will also be paid all arrears on the date of retirement.

11. Responsibility of wrong fixation

The official (s) and authorities involving in fixation of pension / family pension shall be responsible for wrong fixation of pension / family pension if any.

12. This has been concurred in by the Finance Department vide their Noting-130 in OSWAS file No. DAFE-RESH-MISC-0025-2019 of A & FE Department.





No.VJ-53/2019 722 /L, Bhubaneswar, dated the 14th January, 2020

Sub: Revision of Pension/Family Pension in respect of the State Judicial Pensioners, who retired during the period from 01.01.1996 to 31.05.2005 and who retired/died prior to 01.01.1996

Whereas the Govt. have extended the benefit of revision of pension/family pension in respect of the pre-2006 and post-2006 pensioners and family pension holders of Odisha Judicial Service vide Finance Department Resolution No.40733/F dated 22.09.2010 and thereafter para-6 (3) and (13) of the said Resolution have been modified in Resolution No.3511/F dated 09.10.2012 bringing the revision of pension into force w.e.f 01.01.2006.

And whereas on 09.10.2014 para-5 & 6 of the Resolution dated 22.09.2010 in respect of revision of pension /family pension of State Judicial pensioners /family pensioners were modified vide Finance Department Resolution No.28715/F dated 09.10.2014.

And whereas in order to implement the direction of the Hon'ble Supreme Court in I.A No.339 arising out of WP(C) No.1022/1989 accepting the report of Justice Shetty Commission as in Chapter-23 pertaining to the revision of pension/family pension of retired Judicial Officers, who retired during the period from 01.01.1996 to 31.12.2005, the Govt. have been pleased to modify para-5(a) of the Resolution No.28715/F dated 09.10.2014 as follows:

"Para- 5(a)- The pension of Judicial Officers who retired/ died prior to 01.01.2006 but after 01.01.1996 including Judicial Officers whose pension were consolidated as per Karnataka model shall be raised by 3.07 times at par with the other pensioners subject to minimum of 50% of the revised pay scale of pay of their respective posts."

And whereas in compliance of the order dated 14.07.2016, passed in IA No. 1 & 2 arising out of W.P(C) No. 1022 of 1989 of the Hon'ble Supreme Court, the Govt. after careful consideration are pleased to modify para-5(b) of the F.D Resolution No. 28715/F dated 09.10.2014 as follows keeping the eligibility criteria for entitlement of pension enshrined under Rule 47 of the OCS (Pension) Rules, 1992 in view:

"Para 5(b)- The revised pension of the eligible pensioners belonging to State Judicial Service, who retired/died prior to 01.01.1996, shall be 50% of the pay of the post held at the time of retirement, subject to the minimum of 50% of the minimum pay of the post held by them at the time of retirement, as revised from time to time without reference to the number of qualifying years of service."

This Resolution hereby supersedes this Department Resolution No.8881/L dated 30.08.2019 and is concurred in Finance Department UOR No.43-CS-III(M)/F dated 13.05.2019, No.51-CS-III(M)/F dated 11.07.2019 and Finance Department File No.FIN-CS3-PEN-0019-2019.
