Subject: Grant of Dearness Relief on pension to the Pensioners/Family Pensioners of the Teaching & Non-Teaching staff of Non-Govt. Sponsored/Aided Educational Institutions, etc. under Govt. of West Bengal with effect from 1-1-2016 and 1-1-2017

In continuation to this Office Circular No. Pen. Co-ordn./111/Vol.VI//259/Vol-II/244 dated 11/3/2015, it is stated that Govt. of West Bengal, School Education Department, Planning & Budget Branch in their Memo No.242-SE (P&B)/5B-51/2004 and 243-SE (P&B)/5B-51/2004 both dated18/7/2017 have sanctioned Dearness Relief @ 75% and @85% on basic pension/family pension with effect from 1/1/2016 and 1/1/2017 respectively for the Pensioners/Family Pensioners of the teaching and non-teaching employees of Non-Govt. Aided/Sponsored Educational Institutions etc.

The benefit is applicable to the pensioners/family pensioners who are drawing pension/family pension under the scheme D.C.R.B.,1981 of West Bengal Non-Govt. Sponsored/Aided Educational Institutions (Primary & Secondary), as well as the pensioners/ family pensioners who retired/died in harness prior to 01-04-1981 and are governed under GO No. 163-Edn (B) dated 15-06-1990 or GO No. 341-Edn(B) dated 26-11-1993 and whose pension/family pension have been revised/regulated under Memo. No 73-SE(B),dated 19.5.2009 or Memo. No 74-SE(B),dated 19.5.2009 excluding the pensioners of D.A. getting Institutions.

Payment of Dearness Relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of dearness relief to pensioners/family pensioners, such as, regulation of dearness relief on pension/family pension during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., as contained in Finance Department's Memo No. 7533-F dated 06-07-1988 will remain unchanged.

All Pension Disbursing Authorities are, therefore, requested to make necessary arrangements for payment of Dearness Relief @75% with effect from 1-1-2016 and @85% with effect from 1-1-2017 on the basic Pension/Family Pension to the above categories of Pensioners/Family Pensioners whose pension/family pension has been revised as per recommendations of the 5th pay commission, subject to proper adjustment.
