महोदय,

उपरोक्त विषयान्तर्गत वित्त (नियम) विभाग ने अपनी उक्त अधिसूनाओं द्वारा रा. सि. से. (पेंशन) नियम, 1996 के नियम 66(1) एवं नियम 67(B) (C) (D) में परिवार पेंशन प्राप्त करने के लिए क्रमशः परिवार' शब्द की परिभाषा एवं परिवार पेंशन प्राप्त करने की शर्त के "मासिक आय" संबंधी Clause में संशोधन किया है तथा साथ ही पेंशन नियम 77 के उपनियम (ii) व (iii) को विलापित किया है।

राज्यसरकार द्वारा जारी उक्त आदेशों के अनुसार निम्नलिखित प्रावधान किये गये हैं -

(1) पूर्व में अविवाहित पुत्र 25 वर्ष की आयु तक/ अविवाहित पुत्री/विधवा/तलाकशुदा/माता—पिता को रू. 6000/— से अधिक मासिक आय होने पर पारिवारिक' पेंशन की देयता नहीं थी। उक्त आदेशों द्वारा मासिक आय की सीमा को रू. 6000/— से बढ़ाकर रू. 9500/— कर दिया गया है।

(2) पेंशन/पारिवारिक पेंशन में आय के प्रमाण पत्र में रू. 6000/- मासिक के स्थान पर तत्काल रू.

्र**ू** 9500 ∕ − किया जाना वांछित है।

(3) साथ ही नियम 77 के उपनियम (ii) व (iii) को विलापित कर दिया गया है। पूर्व में पारिवारिक पेंशनर के रूप में पेंशन प्राप्त कर रहे पति/पत्नी अगर राज्य सेवा में हैं, तो उन्हें पारिवारिक पेंशन पर महंगाई राहत का भुगतान देय नहीं था। उक्त प्रावधान विलोपित किये गये उपनियमों के अधीन थे। अब विलोपित किये जाने के कारण दिनांक 01.06.2018 से पारिवारिक पेंशनर के रूप में पेंशन प्राप्त कर रहे पति/पत्नी अगर राज्य सेवा में हैं, तो उन्हें पारिवारिक पेंशन पर भी राज्य सरकार के नियमानुसार महंगाई राहत का भुगतान देय होगा।

अतः कृपया आवश्यक कार्यवाही करते हुए राज्य सरकार द्वारा जारी उक्त आदेशों की अनुपालना

सुनिश्चित करावें।



Sir.

On the above mentioned subject, amendment has been made in Rule 66(1) and Rule 67 (B) (C) (D) of R. C. S.(Pension) Rules, 1996, respectively in the definition of the term 'family' for receiving family pension and in the Clause regarding "Monthly Income" in the conditions for receiving family pension and also Sub Rule (ii) & (iii) of Pension Rule, 77 has been deleted by the Finance (Rules) Department, through their Notifications cited above.

The following provisions have been made as per the above orders issued by the State Government -

- (1) Earlier, family pension was not payable to unmarried son below the age of 25 years/ unmarried/widowed/divorced daughter/mother-father, if their monthly income was more than Rs. 6000/-,. Through the above orders, the limit of monthly income has been increased from Rs.6000/- to Rs.9500/-
- (2) In the Income Certificate for pension/family pension, it is required to make Rs.9500/- in place of Rs.6000/- monthly.
- (3) Sub Rule (ii) and (iii) of Rule 77 has been deleted. Earlier, if husband/wife receiving pension in the form of family pension, are in state government service, dearness relief on family pension was not payable to them. The above provisions were under the deleted sub rules. Now consequent to deletion, if husband/wife receiving pension in the form of family pension are in government service, dearness relief on family pension shall also be payable to them as per the rules of State Government, w.e.f. 01.06.2018.

Therefore, you are requested to take necessary action and ensure compliance of the above orders issued by the State Government.

GOVERNMENT OF RAJASTHAN FINANCE DEPARTMENT RULES DIVISION

No. F.12(3)FD/Rules/2010

Jaipur, dated: 2 7 JUN 2018

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2018.
- (2) They shall come into force with immediate effect.
- 2. Amendment of rule 66.- The existing sub-rule (1) of rule 66 of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules, shall be substituted by the following, namely:-
- "(1) 'Family' for the purpose of these rules shall include the following relations of the Government servant:
 - wife, in the case of a male Government servant and (a) husband, in the case of a female Government servant;
 - a judicially separated wife or husband, such separation not being granted on the ground of adultery;
 - unmarried son till he attains the age of 25 years or on (c) earning a monthly income exceeding Rs 9500/- per month, whichever is earlier;
 - unmarried daughter upto the date of her marriage or earning (d) a monthly income exceeding Rs 9500/- per month, whichever is earlier;
 - widowed/divorced daughter of any age upto the date of her (e) remarriage or till the date she starts earning a monthly income exceeding Rs 9500/- per month, whichever is earlier;
 - parents who were wholly dependent upon the Government (f) servant when he/she was alive provided the deceased employee had left behind neither a widow nor a child and the income of parent is not more than Rs. 9500/- per month."

Explanation:- For the purpose of this rule son/daughter shall also include legally adopted son/daughter and posthumous child of a Government servant:

- 2. Amendment of rule 67.- In rule 67 of the said rules, for the existing expression "Rs. 6000/-", wherever occurring, the expression "Rs. 9,500/-" shall be substituted.
- 3. Amendment of rule 97.- The existing clause (b) of rule 97 of the said rules shall be substituted by the following, namely:-
 - "(b) For the purpose of death gratuity,
 - (i) if in any particular case the service book has not been maintained properly despite the Government's order on the subject, and it is not possible for the Head of Office to accept the unverified portion of service as verified on the basis of entries in the service book, the death gratuity shall be paid on the basis of qualifying service verified and accepted by the Head of Office under clause (a), on provisional basis. The amount of death gratuity shall be the amount as indicated in the table below clause (b) of sub-rule (1) of rule 55; and
 - (ii) final amount of the death gratuity shall be determined by the Head of Office on the acceptance and verification of the entire spell of service which shall be done by the Head of Office within a period of six months from the date on which the authority for the payment of provisional death gratuity was issued. The balance, if any, payable as a result of determination of the final amount of death gratuity shall be paid to the beneficiaries.
