The Law Department, Government of Puducherry, has issued orders for extending the revised rates of **Domestic Help Allowance at Rs.2500/- per month and Medical Allowance at Rs.1500/-per month** with effect from 01/01/2006 or from the date of retirement, whichever is later, to all retired Judicial Officers of the Union Territory of Puducherry who had retired as on 01/01/2006 (ie., those who retired on 01/01/2006 and prior to 01/01/2006) and after 01/01/2006 vide G.O.Ms.No.2/2020-LD, dated 18/02/2020, Law Department, Puducherry.

2. On the basis of the above orders, I am to authorize to effect payment of revision of Domestic Help Allowance at Rs.2500/- per month and Medical Allowance at Rs.1500/- per month with effect from 01/01/2006 or from the date of retirement, whichever is later, to all retired Judicial Officers of the Union Territory of Puducherry who had retired as on 01/01/2006 (i.e. those who retired on 01/01/2006 and prior to 01/01/2006) and after 01/01/2006.
