Subject: Non-admissibility of Interim Relief to the pensioners/family pensioners of retired College/University teachers governed under UGC/AICTE Pay Scale

In continuation to this office circular No. Pen. Co-ordin/93 Vol-VI/204/VolI/111/Vol-VII/259/Vol-II/217/Vol-II/258/Vol-II/213 dated 27/06/2016 regarding grant of interim relief to the West Bengal Government Pensioners/family pensioners, it is stated that as per clarification received from the Govt. of West Bengal, Finance Department, Pension Branch and the Higher Education Department, Science and Technology & Biotechnology, C.S. Branch, vide, their Memo No.563/1(300)-F(Pen) dated 30/10/2017 and No. 801/1(13)-Edn(CS)/10M-62/2016 dated 21/7/2017 respectively, the pensioners/Family pensioners of Govt. & Non-Govt. Colleges covered under UGC/AICTE scale of pay, ie, the retired teaching staff including Librarian, Laboratory Instructors, Physical Instructors, Demonstrators of Govt. & Non Govt. Degree Colleges, Engineering Colleges & Polytechnic Colleges are not entitled to get Interim Relief as sanctioned by the Government under Memo No. 224-F(Pen) dated 3/6/2016. The Finance Department, Pension Branch in their communication has also informed that Interim relief, if already paid to such categories of pensioners/family pensioners by the Pension Disbursing Authorities, is liable to be recovered / adjusted from the Pension Relief in five (5) instalment starting from the month of November, 2017.

2. All Pension Disbursing Officers concerned are, therefore, requested not to allow Interim Relief to such categories of pensioners/family pensioners and to take necessary steps to recover the amount, if already paid, as per rules in force, following the guidelines mentioned above.
