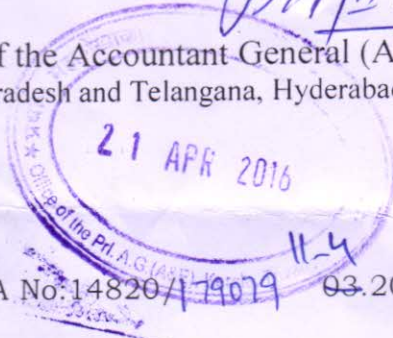

2. In the G.O.2nd read above, Government have accepted the recommendations of the Tenth Pay Revision Commission on the revision of the Pay Scales to Non-Teaching staff of all Universities and decided to extend the fixation benefit of 43% as was allowed to the State Government employees.

3. After careful examination Government hereby order to extend the benefit of consolidation of pension/ family pension to the Non-Teaching Pensioners of all Universities and Aided Institutions including aided Polytechnics as was issued in G.O. 1st readabove and shall apply to mutatis-mutandis.

4. The additional expenditure on account of these orders shall be met within the block grant of Universities.
