Subject: - Grant of dearness relief on pension/family pension to the pensioners/family pensioners of Non Govt. Colleges w.e.f. 1.1.2018

In continuation to this office circular No. Pen.Co-ordn./51/Vol-VI/204/Vol-II/196 dated 14.2.2017, it is stated that the Govt. of West Bengal in their Higher Education, Science and Technology & Biotechnology Department, C.S. Branch in their order no. 1185-Edn(CS)/1P-1/2013, dated 30.10.2017 have sanctioned dearness relief to the pensioners/family pensioners of the teaching and non-teaching staff of the State-Aided Non-Government Colleges in this State @ 100% with effect from 1/1/2018.

All concerned Pension Disbursing Officers are, therefore, requested to allow to the above categories of pensioners/family pensioners dearness relief @ 100% with effect from 1/1/2018 subject to proper adjustment of dearness relief already paid.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions governing grant of dearness relief to the pensioners/family pensioners not mentioned in this order, such as regulation of relief during re-employment, regulation of relief where more than one pension is drawn etc., will remain unchanged.
