**NOTIFICATION**

The Lieutenant - Governor, Puducherry is pleased to make the following rules further to amend the Puducherry Freedom Fighters' Pension Rules, 1970 issued vide G.O. Ms. No.51 Home (I), dated 20<sup>th</sup> July, 1970 of the Chief Secretariat (Home-I) Department, Government of Puducherry and published in the Extraordinary Gazette No.69, dated the 30<sup>th</sup> July 1970, namely :-

1. Short title and commencement :-

(i) These rules may be called the Puducherry Freedom Fighters' Pension (Amendment) Rules, 2020.

(ii) They shall be deemed to have come into force with effect from the 01<sup>st</sup> day of April 2020.

2. Amendment of rule 5: In the Puducherry Freedom Fighters' Pension Rules 1970, (hereinafter referred to as the said rules) in rule 5, (i) for the letters and figures " Rs.8000/- ", the letters and figures " Rs.9000/- ", shall be substituted.

(ii) in the said rule, for the words " in case of others," the following shall be substituted namely, " in the case of State Freedom Fighters."

3. Amendment of rule 6: In the said rules in rule 6, (i) for the letters and figures " Rs.8000/-", the letters and figures " Rs.9000/-", shall be substituted.

(ii) in the said rules, for the words, " in the case of others, " the following shall be substituted, namely, " in the case of State Freedom Fighters".
