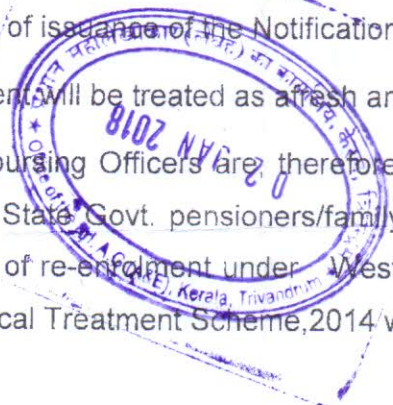
**Subject: - Re-enrolment under West Bengal Health for All Employees and Pensioners Cashless Medical Treatment Scheme,2014 within 31<sup>st</sup> March 2018**

In partial modification of this office earlier circular No. Pen. Co-ordn./212/Vol-II/166 dated 15/11/2011,(issued on the basis of Notification No.8435-F(MED) dated 29/8/2011), it is stated that the Govt. of West Bengal, Finance Department, Medical Cell in their Notification No.953-F(Med)W.B. dated 31/10/2017 have extended a onetime chance to re-enroll under the West Bengal Health for All Employees and Pensioners Cashless Medical Treatment Scheme,2014 to the pensioners and their dependent family members, who have already opted out from the aforesaid Scheme provided that:-

i) The re-enrolment process under the West Bengal Health for All Employees and Pensioners Cashless Medical Treatment Scheme, 2014 should be completed within 31<sup>st</sup> March 2018 from the date of issuance of the Notification.

ii) Their re-enrolment will be treated as a fresh and no retrospective effect be given.

2. All Pension Disbursing Officers are therefore, requested to display the fact on the Notice Board so that the State Govt. pensioners/family pensioners who have already opted out may avail the chance of re-enrolment under West Bengal Health for all employees and pensioners cashless Medical Treatment Scheme,2014 within the stipulated period.
