Sub:- Extension of several benefits to the pre-1.1.2006 pensioner/family pensioner of i)Principal and Lecturer holding pay structure of A.I.C.T.E as per G.O. no. 574-TET(Poly) dated 13/9/2010 under Government Polytechnic.

ii) the employees under Government Polytechnic (except Principal, Lecturer and other categories of staff covered by recommendation of the A.I.C.T.E.)

In continuation to this office circular No.Pen.Co-ordn/248/226 dated 26/3/2014, it is stated that the Govt. of West Bengal, Department of Technical Education & Training, Polytechnic Branch in their Memo. No.323-TET(Poly)/ 4E-03-2011 (Pt) dated 27/3/2017 have adopted certain provisions, contained in Finance Department different Memoranda, for the Principal and Lecturer (holding pay structure of A.I.C.T.E as per G.O. no.574-TET(Poly) dated 13/9/2010) governed under Memo No.999-TET(Poly)/4E-03/2011 dated 18/12/2012 and the employees under Government Polytechnic (except Principal, Lecturer and other categories of staff covered by recommendation of the A.I.C.T.E.) guided by Memo No. 995-TET(Poly)/4E-03-2011 dated 18/12/2012 as mentioned below:-

- The modus operandi in allowing the benefit of para 4.4 of the Memo No.999-TET(Poly)dated 18/12/2012, ie, the revised pension, in no case, shall be lower than 50% of the minimum of the Pay in the Pay Band plus the Academic Grade Pay in the revised Pay Structure corresponding to the pre-revised pay scale from which the pensioner had retired, will be as devised in Memo No.460-F(Pen) dated 20/5/2009 read with 1046-F(Pen) dated 19/11/2009 (circulated under No. Pen. Co-ordn/300/156 dated 28/1/2010). As such, all concerned Pension Disbursing Officers are required to start payment of revised pension provisionally, if it is more than the pension/family pension arrived at in terms of para 4.1 of the Memo 999-TET(Poly)dated 18/12/2012, on receipt of the certificate in this regard directly from the Pension Sanctioning Authority and continue payment of such revised pension/family pension till receipt of final authority in this regard from this office. However, on receipt of final authority for payment of such revised pension/family, to be issued from this office in each individual case, provisional revised pension thus made may be adjusted against the payment of that authority.
- ii) In respect of such categories of pensioners/family pensioners drawing pension/family pension in other State, no such provisional payment of revised pension/family pension as mentioned in para (i) above will be made by the Pension Disbursing Authority. In their cases, the concerned Pension Sanctioning Authority will revise pension/family pension in terms of para

4.4 of the Memo No. 999-TET(Poly)dated 18/12/2012 either suomotu or on receipt of application from the concerned pensioner/family pensioner and send the same to this office for issuing revised authority in each case under special seal and signature to the concerned Accountant General. However, in their cases the revised pension/family pension as determined following the guideline mentioned in the earlier circular dated 26/03/2014 will continue to be paid by the Pension Disbursing Officers till receipt of the authority for revised pension/family pension in terms of para 4.4 of the Memo.

- iii) The guidelines, mentioned in the Government of West Bengal, Finance Department, Pension Branch Memo No.s 635-F(Pen) dated 14/7/2010 and 1025-F(Pen) dated 24/12/2010 (circulated vide No. Pen. Co-ordn/300/92 dated 9/8/2010 and Pen. Co-ordn./300/213 dated 12/1/2011 respectively) are to be followed in allowing additional pension/family pension in terms of para 4.5 of Memo No. 999-TET(Poly) and para 4.4 of Memo No. 995-TET(Poly) both dated 18.12.2012. However, while making payment of additional pension/family pension, the stipulation as contained in Memo. No. 191(350)-F(Pen) dated 16/4/2012 (circulated vide No.Pen.Co-ordn/300/Vol-II/51/Vol-V/111/Vol-VI/50 dated 25/5/2012) as mentioned in para 2(iv) of this office earlier circular dated 26/3/2014 is required to be kept in mind.
- iv) In case of pensioners, guided by both the Memo dated 18/12/2012, who are in receipt of more than one family pension, the overall ceiling of Rs.3300/- will apply to the total of pensions taken together.

All Pension Disbursing Officers are, therefore, requested to keep in mind the above provisions while making payment and send an intimation regarding disbursement of such revised pension/family pension to this office in the form given at Annexure-II to Memo No. 200-F(Pen) dated 25/2/2009 as mentioned in para 3 of this office earlier circular dated 26/3/2014 ibid.

All Accountants General are requested to intimate the aforementioned fact to the concerned Pension Disbursing Authorities under their jurisdiction for taking necessary action as well as to bring the fact to the notice of the pensioners/family pensioners of such categories so that they may accordingly move to the concerned authorities, if required, for having their legitimate claim.
