Sub: Sanction of **Additional quantum of Pension/Family Pension** w.e.f. 01/04/2006 to Pensioners /Family Pensioners of Karnataka State who retired /expired prior to 01/07/1993.

2. Order No.FD(SPL)/27pen 2007, Bangalore dt.13/10/2010 of Govt. of Karnataka.

The Government of Karnataka in their order cited, have ordered to sanction of additional quantum of pension/family pension in r/o Government servants who retired/died while in service, prior to 01/07/1993. The additional increase in the quantum of pension to the above said pensioners/family pensioner is payable w.e.f.01/04/2006 as follows:

	Age of Pensioner/Family Pensioner as	Additional Pension/Family Pension
	on 01/04/2006	from 01/04/2006.
1	From 80 years to less than 85 years	20% of basic pension/family pension.
2	From 85 years to less than 90 years	30% of basic pension/family pension.
3	90 years and above	50% of basic pension/family pension.

As per para No. 9 of the said order, it was stated that, where the date of birth is not indicated in the PPO, the pension sanctioning authority should ensure that the date of birth and age of the pensioner/family pensioner is indicated and sent to the concerned Treasury/Banks to facilitate payment of additional pension/family pension by the pension disbursing authorities.

The Govt. of Karnataka, vide notification No. AE(Spl) 27 PEN2007 dated 6-1-2011 have clarified that in cases where the date of birth of the pensioner/family pensioner is not available in the PPO. The pension disbursing authority may obtain from the pensioner/family pensioner in support of their date of birth, a copy of any of the following documents **duly attested by a Gazetted officer or MLA**, and forward the same to the Accountant General's office for issue of a revised authorisation for additional pension/family pension:

- 1. SSLC Marks card (Incorporating Date of Birth)
- 2. Pan card
- 3. Passport
- 4. Driving License (Incorporating Date of Birth)
- 5. Election ID card

You are hereby authorized to make payment accordingly. Expenditure may be debited 8793/ISS/Karnataka Fraction of rupee shall be rounded of to the next higher rupee. A copy of this letter may be exhibited on the notice board of the treasury.
