

Grant of Interim Relief on pension to the Retired Judicial Officers of the Government of West Bengal and their family pensioners effective from 01/01/2016

Sir,

In pursuance of recommendations of Second National Judicial Pay Commission, the Government of West Bengal in their Judicial Department notification No. 1496-SJ-70/2018 dated 12/04/2018 have allowed interim relief @ 30% on basic pension/family pension in respect of the retired Judicial Officers of the Government of West Bengal with effect from 01/01/2016.

- 2. The increase in pension shall be treated as separate fixed component and no dearness relief is admissible thereon.
- 3. The arrears on pension on account of the component of interim relief thus allowed to be worked out with effect from 01/01/2016 and paid accordingly. The amount payable by the way of interim relief, now proposed, are liable to be adjusted against the amount of pension determined in future, pursuant to the final report submitted by the Commission.
- 4. Payment of interim relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 5. Charges for payment are debitable to the Govt. of West Bengal, under head 2071 Pension and other Retirement Benefits 01 Civil 101 Superannuation and Retirement allowances etc.
- 6. All Pension Disbursing Officers concerned are, therefore, requested to make necessary arrangement for payment of interim relief w.e.f 01/01/2016 or commencement of Pension / Family Pension whichever is later at the rate as mentioned above to all the retired Judicial Officers of the Government of West Bengal and their family pensioners.
