Subject:-Online Enrolment of the name of the family members suffering from critical diseases under a new category Relationship(Critical Diseases)" under "Health Scheme"

The Govt. of West Bengal, Finance Department, Medical Cell in their Memorandum No.35-F(Med)W.B. dated 24/04/2018 have pleased to relax the income limit for parents, son, minor brother, unmarried /widowed/divorced daughter, unmarried /widowed/divorced sister for medical treatment of life threatening Critical diseases like (i)Cancer,(ii)Liver transplant,(iii)Kidney transplant and (iv)Major Heart Surgery.

- 2. Accordingly, Govt. has extended the benefit to enroll or include those family members of the employees/pensioners under All Employees and Pensioners Cashless Medical Treatment Scheme, 2014 (hereinafter called the Health Scheme), if the dependents are not covered under any other Government Health Scheme which offers similar facilities. However, the said dependent members of the pensioner having a Medical Insurance Policy would be allowed to claim reimbursement of only residual medical expenses left after claim of the Insurance Company has been settled.
- 3. A medical claim against the original vouchers/cash-memos would be raised by the dependent members first from the Insurance Company, who would issue a certificate for the amount of settlement. He would then prefer his medical claim alongwith the certificate and photocopies of vouchers/cash memos of the medical treatment to the concerned office.
- 4. The CCA/Head of office/PSO would then reimburse to the Government employee/pensioner only the balance admissible amount on the basis of approved rates i.e. admissible amount minus the amount reimbursed by the Insurance Company..
- 5. All Pension Disbursing Officers are, therefore, requested to display the fact on the Notice Board so that the State Govt. pensioners may avail the facility to enroll the name of his/her aforesaid family members, online under a new category "Relationship(Critical Diseases)", subject to the condition mentioned above.
