

Subject : Grant of Interim Relief to all West Bengal Govt. pensioners/
family pensioners with effect from 01-07-2016.

In continuation to this office circular No. Pen.Co-ordn./93 Vol-VI/204/Vol-II/111/Vol-VII/259/Vol-II/217/Vol-II/258/Vol-II/213 dated 27/06/2016 It is informed that as per clarification received from the Govt. of West Bengal, Finance Department, Pension Branch the benefit of **interim relief @ 8%** on basic pension/ family pension with effect from **01/07/2016** is payable to the following categories of West Bengal Govt. pensioners/family pensioners .

- i)) Holders of Ad-hoc Family pension;
- ii) Pensioners who are drawing provisional pension both under Rule 137 & 10(2) of W.B.S.(D.C.R.B.) 1971;
- iii) Holders of interim allowance under Rule 14 of the W.B.S.(D.C.R.B.) Rules, 1971;
- iv) Holders of compassionate allowance under Rule 12 of the W.B.S.(D.C.R.B.) 1971;
- v) Holders of pro-rata pension under Rule 189A as well as pensioners who are getting restored amount of pro-rata pension in terms of Memo No. 2430-F dated 12/7/2001.

Moreover, it is stated that payment of Interim Relief on pension /family pension involving a fraction of rupee shall be rounded off to the next higher rupee as admissible in case of payment of dearness relief on pension/family pension.
