Sub: Grant of Dearness Relief to Pensioners and Family Pensioners of Union Territory of Puducherry – Revised rates effective from 01/07/2016 – Reg.

The Government of India have revised the rate of Dearness Relief on Pension/family Pension with effect from 01/07/2016 at the rate of 2% in O.M. F.No.42/15/2016-P&PW(G), dated 16/11/2016 of the Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners' Welfare, New Delhi.

2. The Government of Puducherry has communicated the Orders of Government of India for extending the revised rate of Dearness Relief @ 2% with effect from 01/07/2016 to the Pensioners / Family Pensioners of the Union Territory of Puducherry vide G.O.Ms. No.51/F3/2016-17, dated 12/01/2017 of the Finance Department, Puducherry.

3. On the basis of the above orders, I am to authorize to effect payment of Dearness Relief at the revised rate of 2% as mentioned above with effect from 01/09/2016 to all eligible Pensioners/Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks/Treasuries/Sub-Treasuries under your control subject to conditions governing the payment of Dearness Relief on Pension/Family Pension as detailed in the Government of India Office Memorandum aforesaid.

4. Separate orders will be issued for payment of arrears on account of the Dearness Relief to the pensioners for the period from 01/01/2016 to 31/08/2016.
