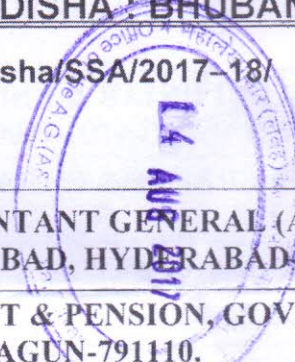



RESOLUTION

No. 27386 /, Bhubaneswar, Dated the 19.07.2017

Sub: Enhancement of Second World War Veterans pension in favour of the WW-II Veterans and their widows belonging to the State of Odisha.

The Government in Home Department Resolution No.19982 dated 31st March, 2001 had implemented a Scheme for payment of monthly pension to the non-pensioner Second World War Veterans who are bonafide residents of Odisha with effect from 1st April, 2001. Subsequently, in the year 2009 Govt. in Home Department had been pleased to enhance the said monthly pension from Rs.500/- to Rs.1000/- only in favour of the non-pensioners Ex-servicemen/women of Odisha who had participated in the 2nd World War vide this Department Resolution No.38644 dated 20.8.2009.

Now, it is decided to extend the benefit of this monthly pension in favour of the widows whose husbands have expired after the pension was sanctioned to them by Home Department Resolution No.36511 dated 31.8.2006 provided that the widows are over 60 (sixty) years of age.

Now, after careful consideration, Government have been pleased to enhance this monthly pension from Rs.1000/- (Rupees One Thousand) to Rs.6000/- (Rupees Six Thousands) only in favour of the non-pensioners Ex-servicemen/women of Odisha who had participated or served in the 2nd World War and also to the widows whose husbands have expired after this pension was sanctioned to them by the Home Department, provided that the widows are over 60 (sixty) years of age.

(a) In the third paragraphs, the quantum of 2nd World War Veteran Pension of Rs.1000/- (Rupees One Thousand) only shall be replaced as Rs.6000/- (Rupees Six Thousand) only.

The enhanced quantum of 2nd World War Veteran Pension shall be made effective from the date of issue of the Resolution and all other terms & conditions would be operational as before.

This has been concurred in by the Finance Department Vide their U.O.R. No.07/GS-1 dtd.05.11.2016.

Order: Ordered that the Resolution be published in the Extraordinary issue of the Odisha Gazette.
