The Government of Rajasthan had clarified in it's letter cited 2nd that minimum pension/family pension of Rs. 3450/p.m. w.e.f.01-07-2013 is payable by the Treasury Officer. For this the following procedure may be adopted:-

In the cases of Pro rata Pension, Ex-gratia payable to the widows of CPF holders of Jodhpur state, lumpsum pension payable to the pensioners of former Indian princely states, pension payable to the legal heirs of Tonka family, pension payable to the freedom fighters etc. minimum pension/family pension of Rs.3450/-p.m.is not payable. As such family pension, which is divided into more than one person, in such cases also family pension @ Rs. 3450/- p.m to each pensioners is not payable.

On the reference cited 3rd it is directed for sending the revised proforma of Life Certificate enclosed to the subordinate branches and obtain the life certificate in the revised proforma.

In this context you are requested that if any pensioner is giving Life Certificate without the additional information in the prescribed proforma, it may be accepted and the pension may be continued.

You are hereby authorized to make action accordingly.
