The following guidelines/criteria in this regard may please be noted.

#### The other conditions for nominations are: -

- (i) Officers recommended should not expect promotion to the next grade till the end of posting in overseas audit Offices. However, those willing to forego promotion till the end of their tenure in overseas audit offices are eligible.
- (ii) Officers/Officials have had a posting abroad (including Bhutan) either in our offices or in other offices and on Deputation/foreign service outside department are not eligible. No exemption from this condition will be granted.
- (iii) Officers (Sr. AO/AAO) posted abroad are required to serve in C&AG's Office, New Delhi for three years on return. Only those officers who are willing for posting to Headquarters at New Delhi on return, should apply. However, this would not be applicable in the case of Sr. PSs/PAs.
- (iv) Officers/Officials had earlier been on Deputation, in India, outside IA&AD, must have completed a compulsory cooling-off period of 3 years in the department, as on 01-01-2025, before they are considered for this assignment.
- (v) Officers/Officials should be clear from vigilance and disciplinary angle and should not have been awarded minor/major penalty in the past.

- (vi) Officers must have adequate experience in audit and proficiency in computer software applications, particularly MS Office is a must.
- (vii) Officers should possess substantially high capacity to do original work and the officers and their dependents should possess an ability to get along with others and to maintain dignity and decorum in personal and official life
- (viii) The officers commitments at home should not be such as would hamper their effective performance of their official duties abroad.
- (ix) The officers must have a small-sized family. The souse should be able to speak and write English fluently.
- (x) The officers and their family should be good representatives of the country.
- (xi) Education of college going children is very expensive abroad and posting abroad should not cause dislocation to family. Officers with younger children will be preferred. If selected and deputed for posting broad, no requests for extension of tenure, for any reason whatsoever, will not be entertained.
- (xii) The officers nominated and his/her family should have a cosmopolitan attitude and be flexible in their habits.

The willing Sr. AOs/AAOs (Civil Cadre) & Sr. PS/PAs posted in this office may submit their complete bio data in the prescribed proforma (Annexure III) to Confidential Cell through mail at aaocc.del.ica@cag.gov.in by 11.02.2025 (Tuesday), 5:00 P.M.
