

Subject:- Implementation of the decision of state government regarding the recommendations of Uttar Pradesh Pay Committee (2016)- Amendment of the provisions regulating Pension/Gratuity/Commutation of Pension/ Family Pension/Disability Pension/Lump sum Ex-gratia amount.

Sir,

Inviting your attention on the above subject, the undersigned is directed to say that after issuing Resolution no. 62/2016/P.C.-2-2643/X-04(M)/2016 dated 16.12.2016 by the State Government, after due consideration of the recommendations of Part -2 of the first report of Pay Committee, Uttar Pradesh (2016), the Honourable Governor is pleased to order the following amendments in the provisions regulating the provisions of pension/family pension/gratuity and commutation of pension of government employees retired/deceased on or after 01.01.2016.

2.- This order will be applicable to those State Government employees governed by Uttar Pradesh Civil Service Regulations who are entitled to receive pension/family pension and other retirement benefits under Uttar Pradesh Liberalised Pension Rules 1961, Uttar Pradesh Retirement Benefit Rules 1961, New Family pension Scheme 1965 GO No. Gen-3-969/X-923/85 dated 08.08.1986 and will retire/decease on or after 01.01.2016. This order will also be applicable to the pensioners receiving pension under Disabled Pension and Extra Ordinary Pension Rules (Except Extra Ordinary Pension of non government persons). But this order will not be applicable to Judges of High Court, Chairman and members of Public Service Commission, non Government employees of Education Department, employees of Local Bodies and Public Undertakings etc.

3-(1) Date of effect

The provisions being made under this order is applicable to those government employees retired/deceased on or after 01.01.2016. Separate orders are being issued regarding the revision pension/ family pension of pre 01.01.2016 retired/deceased government employees.

3-(2)

Revision of pension of those Government servants covered by these orders in whose case sanction of pension/family pension/death cum retirement gratuity and commutation of

a portion of pension has been issued as per the previous provisions, will be done under the procedure mentioned in this order. If the revision of pension/family pension under the procedure mentioned in this order is not beneficial to the pensioner, no such revision will be done in those cases.

4 (1) Emoluments

Emoluments for calculation of pension and other retirement benefits (apart from retirement/death gratuity) means the pay as defined in Fundamental Rule-9(21)(1) and which the employee was receiving immediately before his/her date of retirement or on the date of death.

4(2)

Based on the recommendation of Uttar Pradesh Pay Committee (2016), the basic pay in the revised pay structure means the pay which has been drawn at the fixed level in the pay matrix applicable w.e.f. 01.01.2016, but no other type of pay viz. special pay etc will be included.

4(3)

For the calculation of retirement/death gratuity the dearness allowance payable on the date of retirement/death will be included in the emoluments.

5-Pension

5-(1)

Under the provisions of Article - 474 Civil service Regulations, pension is not admissible to those Government servants who retire before completing 10 years of qualifying service, but the employees of the above mentioned category shall be eligible for receiving service gratuity as per State Government Rules.

5-(2)

In continuation to the recommendations of Uttar Pradesh Pay Committee (2008), full pension is admissible to the employees retiring on or after 01.01.2016 who have completed 20 years of qualifying service. This provision has been kept the same in the recommendations of Uttar Pradesh Pay Committee (2016). Pension equal to 50 percent of the last pay drawn is admissible to those employees who retire after completing 20 years of qualifying service. If the qualifying service is more than 10 years but less than 20 years then the amount of pension will be reduced proportionally but under no circumstances the amount will be less than ₹9000/- per month.

5-(3)

The minimum amount of pension will be Rs 9000/- per month and the maximum amount shall not be more than 50 percent of the highest pay in the State Government.

5-(4)

Additional pension / family pension received by the old age pensioners/family pensioners will be admissible as earlier as given below :-

Age of pensioner/ family pensioner	Amount of additional pension/ family pension
More than 80 years, but less than 85 years	20% p.m. of basic pension/family pension
