Revision of pension / family pension of retired employees

of the High Court, Calcutta

In continuation to this office circular No. Pen. Co-ordn./22 Vol.III/168 dated 17/02/2010, it is to state that the Hon'ble Chief Justice, Calcutta High Court as an interim measure has adopted provisions contained in all relevant Rules / Orders / Circulars / Notifications issued so far by the State Government for application with respect to revision of pre-2016 and post 2016 pensioner of State Government by issuing an order bearing No. 255-G dated 27/01/2020.

Consequent upon such adoption till finalization of revision of pension/family pension by the Special Pay Commission to be constituted for such categories of pensioners/family pensioners in due course, the employees of High Court, Calcutta who retired prior to 01/01/2016 are now entitled to get the benefit of revised rates of pension / family pension w.e.f. 01/01/2020 in line with the methodology stipulated in the circular bearing No. Pen. Co-ordn./345/162 dated 20/01/2020 (uploaded in this office portal under link agwb.cag.gov.in/agae/circular_office_order) already issued in this regard with respect to pre-01/01/2016 pensioners of Government of West Bengal. Besides, the modus operandi for allowing revised pension/family pension provisionally to the post 2016 High court staff pensioners/family pensioners will be same as has been mentioned in this office circular No. Pen Co-ordn./345/195 dated 12/03/2020 and uploaded in this office web site as stated earlier.

On receipt of communication on the above matter from the Registrar General, High Court Calcutta under No. 291-G dated 28/01/2020, all concerned Pension disbursing officers are requested to make necessary arrangements for payment of pension/family pension at the revised rate keeping in view of the instructions given in above mentioned circulars.
