



Government of West Bengal in their Technical Education, Training and Skill Development Department letter bearing No. 1412-TET (Poly)/5P-10/2019 (Pt I) dated 24/12/2019 has accorded sanction for revision of pay structures for Principals and Lecturers of Government Sponsored Polytechnics and allowed the pensionary benefits to the retired employees of mentioned categories as per extant rule of the State Government.

Consequent upon such extension of pensionary benefits to the mentioned categories, retired Principals and Lecturers of Government Sponsored Polytechnics who retired prior to 01/01/2016 are now entitled to get the benefit of revised rates of pension / family pension w.e.f. 01/01/2020 in line with the methodology stipulated in the circular bearing No. Pen. Co-ordn /345/162 dated 20/01/2020 (uploaded in this office portal under link [agwb.cag.gov.in/agae/circular\\_office\\_order](http://agwb.cag.gov.in/agae/circular_office_order)) already issued in this regard with respect to pre-01/01/2016 pensioners of Government of West Bengal.

Besides, the modus operandi for allowing revised pension/family pension to the post 2016 pensioners/family pensioners of the mentioned categories will be same as has been mentioned in this office circular No. Pen Co-ordn./345/195 dated 12/03/2020 and uploaded in this office web site as stated earlier.

All concerned Pension Disbursing Officers are requested to make necessary arrangements for payment of pension/family pension at the revised rate to the above categories of pensioners / family pensioners following the instructions mentioned in circulars dated 20/01/2020 and 12/03/2020 respectively, subject to proper adjustment.
