6. पेंशन पर महंगाई राहत का भुगतान पुनर्नियोजित पेंशनरों सहित उन पेंशनभोगियों को भी देय होगी जिन्हें क्षतिपूर्ति पेंशन, वार्धक्य पेंशन, सेवानिवृत्ति एवं असमर्थता पेंशन प्राप्त है। औपबंधिक पेंशन/पारिवारिक पेंशन एवं असाधारण पेंशन पानेवाले को भी यह राहत देय होगी।

7. पेंशनभोगियों को इस महंगाई राहत के भुगतान में विलम्ब के परिहार हेतु बिहार कोषागार संहिता, 2011 के नियम 206 के अन्तर्गत महालेखाकार, बिहार से बिना प्राधिकार के ही राहत के भुगतान का आदेश राज्य के अन्दर पेंशन लेने वालों के मामले में दिया जाता है। कोषागार पदाधिकारियों को यह भी निदेश दिया जाता है कि बैंकों के माध्यम से भुगतान प्राप्त करने वाले पेंशनभोगियों को त्वरित भुगतान कराने के लिए वे सार्वजनिक क्षेत्र के सभी अधिकृत बैंकों को इसकी प्रतियाँ भेज दें। बिहार राज्य के बाहर महंगाई राहत की निकासी महालेखाकार, बिहार के प्राधिकार पत्र पर ही की जा सकती है। महालेखाकार, बिहार से अनुरोध है कि राज्य के बाहर पेंशन प्राप्त करने वाले पेंशनभोगियों से संबंधित महालेखाकारों को अविलम्ब पेंशन राहत भुगतान के लिए प्राधिकृत किया जाय तथा इसकी सूचना वित्त विभाग को भी दी जाय।

8. दिनांक-01/07/2016 के प्रभाव से स्वीकृत महंगाई राहत भुगतान करते समय पूर्ववर्ती कंडिकाओं में निहित प्रावधानों का दृढ़ता से पालन किया जाय तथा इस मद में भुगतान की जाने वाली राशि की शुद्धता की जांच हर हाल में प्रत्येक भुगतान के समय कर ली जाय। ऐसा करना भुगतान करने वाले पदाधिकारी की जिम्मेदारी होगी।

आदेश- आदेश दिया जाता है कि इस संकल्प को बिहार राजपत्र के अगले अंक में सर्वसाधारण की जानकारी हेतु प्रकाशित किया जाय।

RESOLUTION

Patna, Dated 05.05.2017

Sub :- Sanction of 136% DR in the place of 132% to State Government Pensioners/ Family Pensioners receiving pension in pre revised pay scale, i. e. sixth central pay scale w.e.f. 01.01.2017.

Vide Department of Finance, Resolution No. 9386 dated 09.12.2016, DR at the rate of 132% has been sanctioned to State Government pensioners/family pensioners w.e.f. 01.07.2016.

2. Vide Government of India, Finance Department OM No. 1(3)/2008-E-II(B) dated 07/04/2017, the rate of DA to Central Government Pensioners/Family Pensioners receiving pay in pre-revised pay scale i. e. sixth central pay scale has been enhanced from 125% to 132% w.e.f. 01/07/2016.

3. State Government has also been sanctioning DA/DR to their employees/pensioners/family pensioners at the same rate and from the same date in accordance with central government.

4. Pay revision has not been done by the State Government w.e.f. 01.01.2016 and State Employees are receiving pre-revised pay on the basis of sixth central pay scale.

5. In view of the above, the State Government after due consideration have decided that :

- (i) Payment of DR on revised pension shall be made to State Government pensioners/family pensioners at the rate of 136% in the place of 132% w.e.f. 01.01.2017.
- (ii) Payment of DR shall be calculated on the basis of basic pension.
- (iii) In the calculation of DR 50 paise or more shall be rounded off to next higher rupee and the amount less than 50 paise shall be ignored.
- (iv) Payment of the amount of above DR shall be made in cash.
- (v) Payment of above DR on revised pension to the pensioners of High Court/Bihar Legislative Assembly/ Bihar Legislative Council shall be made with the sanction of the Chief Justice, High Court, Patna/Speaker, Bihar Legislative Assembly/Chairman, and Bihar Legislative Council.

6. Payment of DR on pension is admissible to those pensioners, including re-employed pensioners also, who are receiving compensatory pension, old age pension, retirement and invalid pension. The relief shall also be payable to those receiving provisional/family pension and extraordinary pension.

7. In order to avoid delay in the payment of DR to pensioners, orders are issued under Rule 206 of Bihar Treasury Code, 2011 for payment of relief without the authorization of the Accountant

General, Bihar in the case of pensioners receiving pension within the state. The Treasury/Sub Treasury Officers are also directed to circulate the copies of this order to all authorised Public Sector Banks for making immediate payment to the pensioners receiving payment through banks. Release of DR outside Bihar State shall be made only on the authorisation letter of the Accountant General, Bihar. The Accountant General, Bihar is requested that the Accountants General concerned with the pensioners receiving pension outside Bihar State shall be authorized urgently for the payment of relief on pension under intimation to the Department of Finance.

8. While making payment of the DR sanctioned w.e.f. 01.07.2016, the provisions contained in the previous paras shall be strictly adhered to and the accuracy of the amount being paid under this item shall be checked during each payment, in any case. It shall be the responsibility of the officer making payment.

ORDER - Ordered that this Resolution be published in the next edition of the Gazette of Bihar for the information of general public.
