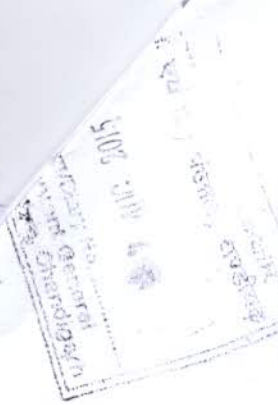

Sir,

I am directed to refer to this Department's Letter No. 3/2/97-1FP-1/259 dated 20.3.2015 on the subject cited above and to convey that the Governor of Punjab is pleased to release the 6% instalment of Dearness Relief due w.e.f 1-1-2015 which is payable from August 2015 to the Punjab Govt. Employees and pensioners. With this instalment the Dearness Relief of the employees / pensioners shall stand increased from the existing rate of 107% to 113% of basic pay/ pension.

2. The arrears of dearness relief for the period from 1.1.2015 to 31.7.2015 will be paid alongwith salary of October 2015.
