The Government of West Bengal had sanctioned revised rates of Dearness relief @ 75 % w.e.f. 01/01/2016 to their State Government pensioners/Family Pensioners vide memo .No.700-F(Pen) dated 16/12/2015 of Finance Department, Pension Branch.

You are requested to make necessary arrangements for payment of Relief to the above categories of Pensioners/Family Pensioners @ 75 % w.e.f. 01/01/2016 after proper adjustment.

This benefit of Dearness Relief as has been sanctioned in the aforesaid Memorandum for the State Govt Pensioners/Family Pensioners will also be allowed to the teaching and Non-teaching pensioners of State aided Non-Government Educational Institutions and Pensioners of Statutory Bodies/Government Undertakings/Panchayats including Panchayat Karmee and Municipal Corporations/Municipalities/Local Bodies etc. who are in receipt of Dearness Relief @ 65% of basic pension with effect from January 01, 2015. In such cases the respective Administrative Department may sanction the benefit of Dearness Relief @ 75% with effect from January 01,2016 to the pensioners concerned under their control.

Payment of relief on pension/family pension involving a fraction of rupee shall be rounded off to the next higher rupee.

The expenditure is debitable to 8793/ISS/West Bengal.
