Sub **FORWARDING OF GOVERNMENT OF NAGALAND, . FINANCE DEPARTMENT'S NOTIFICATION NO. FIN/ESTT-2/11/VII-CPC/16 DATE 16.12.2017 REGARDING REVISION OF PAY AND PENSION OF NAGALAND GOVERNMENT PENSIONER/ FAMILY PENSIONERS.**

Sir/Madam,

In inviting a reference to subject cited above. I am to forward here with the Government of Nagaland, Finance Department's NOTIFICATION No.FIN./ESTT-2/11/VII-CPC/16 Dated 16.12.2017 for revision of Pension in respect of the Nagaland Government Pensioners/Family Pensioners who retired/ died prior to 01.06.2017.

Revision of Pension/family Pension for existing state pensioners/ family Pensioners who retired/ died prior to 01/06/2017.

As per Para (I) (ii), The existing pension/family pension as had been fixed under the Nagaland Services (ROP) Rules, 2010 shall be multiplied by factor of 2.57 to arrive at an alternate value for the revised Pension/family pension W.E.F.01/06/2017. The term existing pension/family pension shall mean the basic pension before commutation. Hence, the commuted portion of pension shall be deducted from the revised pension/ family pension to arrive at the actual amount payable..

The cash benefit of the revised pension/family pension shall however be payable only w.e.f.01/01/2018 and no arrears for the period 01/06/2017 to 31/12/2017 shall be admissible.

All Pension Disbursing Authorities including Public Sector Banks handling disbursement of Pension of the government of Nagaland Pensioners/ family Pensioners are authorized to pay the revised Pension/Family Pension to the Pre 01/06/2017 Pensioners/family pensioners based on the second formulation indicated at rule 15 (I) (ii) above w.e.f. 01.01.2018 on provisional basis. The detailed instructions in regards to the revision of fpension/family pension in terms of the first formulation mentioned at (I)(i) shall be notified separately.

You are, therefore requested to circulate the Notification to all pension Disbursing Authorities under your jurisdiction for necessary action please.
