ORDER:

In the reference 2nd read above, Government have issuedorders for consolidation of pension which, inter-alia, mentioned about the applicability of the orders to pensioners who retired prior to 01.01.1996 drawing UGC scales. The intention of the Government was never to confer benefit of consolidation of pension adopting state DR pattern to those who are in receipt of Dearness relief in Government of India pattern. Para 16 (i) of the G.O. 2nd read above makes the intention of Government clear.

- 2. In the reference 3rd read above, the DTA, Telangana, Hyderabad has requested to clarify on consolidation of pensionadopting state DR pattern for those who are drawing pensions based on UGC scales, stating that there is no order issued by the Government in this regard. The DTA has further stated that some of the UGC pensioners are seeking consolidation of pension adopting state DR pattern.
- 3. Government, after careful examination of the issue, here by clarify that the orders have already been issued vide reference 1st read above, for consolidation of pension allowing Central Dearness Relief w.e.f. 1.1.1996 to the UGC pensioners from time to timeas per the Government of India guidelines in supersession of the orders issued in G.O. (P).No.95, Finance (Pension. I) Department, dt.01.08.2000.

4. Accordingly, Government hereby issue the following amendment to the G.O. 2nd read above:

AMENDMENT

In the existing para 15 sub para (1) (iii) shall stand deleted with effect from 07-04-2015.
