Sub: Grant of FIXED MEDICAL ALLOWANCE to Pensioners and Family Pensioners of Union Territory of Puducherry – Revised rate effective from 19.11.2014– Orders – Communicated.

The Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Pension & Pensioners' Welfare), New Delhi in its O.M. No.4/25/2008-P & PW (D), dated 19.11.2014 have revised the rate of Fixed Medical Allowance payable to the Central Government Pensioners/Family Pensioners residing in areas not covered under Central Govt. Health Scheme administered by the Ministry of Health & Family Welfare and corresponding Health Schemes administered by other Ministries/Departments for their retired employees for meeting expenditure on their day-to-day medical expenses that do not require hospitalization, with effect from 19.11.2014 at the rate of Rs. 500/-p.m.

- 2. The Government of Puducherry has communicated the Orders ibid for extending the revised rate of Fixed Medical Allowance to the Pensioners/Family Pensioners of the Union Territory of Puducherry vide I.D. Note/O.M. No.G.12011/1/2010/F-3-II dated 28.11.2014 of the Finance Department, Puducherry.
- 3. I am therefore to authorize you to effect payment of Fixed Medical Allowance at the revised rate of Rs.500/-p.m. with effect from 19.11.2014 to all eligible Pensioners/Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks/Treasuries/Sub-Treasuries under your control subject to conditions governing the grant of Fixed Medical Allowance as enunciated in the Government of India Office Memorandum aforesaid.
