

Preamble: -

In pursuance of the recommendations of the 7th Central Pay Commission, the State Government has decided to sanction revised pension vide resolutions dated 15/10/2016 cited above for Pensioners / Family Pensioners of the State Government. According to the State Government's decision, the actual implementation of revised pension as per the 7th Pay Commission to the Pensioners of the state started from Dt.1/10/2016. In pursuance of the decision of state government, the amount of difference of revised pension of nine (9) months from Dt.1/1/2016 to Dt.30/9/2016 is to be paid to the Pensioners / Family Pensioners of the state.

Considering the representations made employees' associations/federations and pensioner's associations of the state regarding payment of the amount of difference of pay-pension, Honorable Deputy Chief Minister has, in the interest of the employees and pensioners of state government, taken a decision in the Legislative Assembly on Dt.1/3/2018 by making statement under Rule-44 of Legislative Assembly Rules to pay the above amount of difference in cash in three instalments during current year.

Resolution .

In view of the above decision, it is decided to pay first installment of the amount of difference of 7th Pay Commission to the pensioners in March, second installment in May and third installment in July during current year.

The State Government has decided 2% temporary increase to the pensioners from 1-10-2016 to 31-12-2016 vide G.R. as mentioned (3) above. The amount of difference of three months from 1/7/2016 to 30/9/2016 to the pensioners



was not paid to facilitate easy calculation of the amount of difference. That admissible amount shall be paid under this order.

If any variation in the amount of difference regarding pay verification is found, the same shall be adjusted against the instalment of payment of amount of difference payable to the pensioners.

It will be the responsibility of the Pension Disbursing Authority, to calculate instalment of payment of amount of pension difference payable in each individual case.

All Accountant General of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to The State Government Pensioners / family pensioners drawing pension / family pension from their State Treasuries, Including Public Sector Banks.
