Ref: Resolution no. - 754 & 755 dated 20.10.2017 of Department of Finance.

Sir,

On the above mentioned subject it is stated that in para-4 & para-5 of Department of Finance, Resolution no. 754 & 755 respectively dated 20.10.2017 issued for the revision of pension of the pensioners/family pensioners of State Government in light of the recommendation of State Pay Commission, it is mentioned that "The amount of medical allowance admissible to the pensioners / family pensioners will be the same as permitted by the State Government to the serving employees of the State Government"

- 2. Vide Resolution no. 8043 dated 11.10.2017 of Department of Finance, Rs.1000/-(Rupees One Thousand only) p.m. has been sanctioned as medical allowance to the employees of the State Government.
- 3. Therefore, in light of the above Resolutions of Department of Finance it is clarified that Rs.1000/- (Rupees One Thousand only) will be admissible as medical allowance to the pensioners/family pensioners of State Government which will be effective from the date of issue of the Resolution (754/755) i.e 20.10.2017.
