No.FIN/ROP/REL-8/87(Vol-II) dated 30-5-2018 to grant the Dearness Relief to the State Government pensioners/family pensioners for the purpose of fixation of pension under the Nagaland Services (Revision of Pension) Rules at the following rates.

1. 7<sup>th</sup> ROP Rules With effect from 01-1-2018 :-7%
2. 6<sup>th</sup> ROP Rules With effect from 01-1-2018 :- -142%

Apart from these the Government of Nagaland, Departmental of finance ROP cell O.M. Vide No. FIN/Rop/Rel-8/87Vol-II dated 26/10/10 standing order of release of Dearness Relief to the Nagaland, State Government pensioners/Family pensioners as when sanctioned by the Government of India without any further order from the State Government or authorization from the Accountant General has been kept in abeyance till further notice (vide Finance Department, Government of Nagaland No. FIN/ROP/REL-8/87/(Vol.II) dated 26<sup>th</sup> February 2016). In future for Revision of Dearness Relief, separate authorisation will be issued as and when the same is revised by the State Government of Nagaland.

1	7 <sup>th</sup> ROP Rules	5%	7%	2%	01.01.2018
2	6 <sup>th</sup> ROP Rules	139%	142%	3%	01.01.2018

2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
3. The Accountant General, Nagaland, is requested to circulate this O.M. to the Accountants General of all States so that Pensioners of the Government of Nagaland drawing pensions under their jurisdiction may be authorized for payment of this relief at the earliest.


