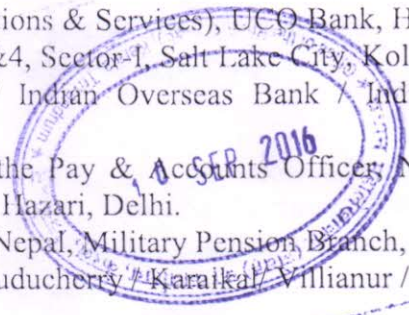

In the O.M. 1<sup>st</sup> cited, Government of India have decided that the Ex-French Pensioners / Family pensioners of Government of Puducherry governed under pre-merger (Ex-French) Pension Rules are also eligible for benefits of revision of pension with effect from 01/01/2016. However, the order regarding revision of pension as per pay fixation method available to the Central Government Pensioners vide this Department's O.M. No. 38/37/2016-P&PW(A) dated 12-05-2017 shall not be applicable to these Ex-French pension Rules Pensioners / Family Pensioners. They are also eligible for Dearness Relief at revised rates as per orders issued by the Government of Puducherry in this regard from time to time.

2. The Pension Disbursing Officers are hereby authorized to revise the Pension/Family Pension in respect of Ex-French Pensioners / Family Pensioners to Government of Puducherry by multiplying the pension / Family Pension, as had been fixed at the time of implementation of the 6<sup>th</sup> Central Pay Commission's recommendation by 2.57. The Revised pension structure to the Ex-French Pensioners / Family Pensioners shall be given effect from the month of September 2016. Orders for payment of arrears from 01/01/2016 to 31/08/2016 will be issued separately.

3. The above mentioned benefits shall not, however be admissible in the case of the Pensioners/Family of the deceased Pensioners who had opted for French Nationality and are drawing Metropolitan Pension from the French Government.
