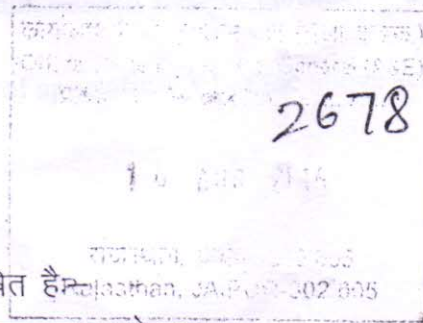

राजस्थान सिविल सेवा (पेंशन) नियम, 1996 के परिशिष्ट-VI (पब्लिक सेक्टर बैंकों द्वारा राजस्थान सरकार के सिविल पेंशनरों की पेंशन के संदाय के लिए स्कीम) में इसके द्वारा निम्नलिखित संशोधन किये जाते हैं:-

1. उपर्युक्त नियमों के परिशिष्ट-VI के विद्यमान पैरा 15 के स्थान पर निम्नलिखित प्रतिस्थापित किया जायेगा, अर्थात:-

"15. पेंशनर की मृत्यु की सूचना प्राप्त होने पर बैंक की संदाय शाखा पेंशनर के मृत्यु प्रमाण पत्र के साथ-साथ कुटुम्ब पेंशन के संदाय के लिए उपाबंध-V में एक आवेदन प्राप्त करेगी और पेंशन संदाय आदेश के संवितरक के भाग में निदेशक, पेंशन द्वारा उपदर्शित दरों पर कुटुम्ब पेंशन संदाय प्रारम्भ करेगी। संदाय शाखा पेंशन संदाय आदेश के संवितरक के भाग और उपाबंध-III पर के प्ररूप में के रजिस्टर में पेंशनर की मृत्यु की तारीख दर्ज करेगी। किसी विधिक विवाद के मामले में बैंक के अभिलेख में संधारित संवितरक के भाग को विधिमान्य दस्तावेज के रूप में माना जायेगा।"

2. उपर्युक्त स्कीम के परिशिष्ट-VI का विद्यमान पैरा 15.3 हटाया जायेगा।

Sub :- Amendment in Appendix – VI of Rajasthan Civil Service (Pension) Rules, 1996 (Scheme for payment of pension of civil pensioners of Rajasthan Government by Public Sector Banks).

The following amendments are hereby made in appendix – VI of Rajasthan Civil Service (Pension) Rules, 1996 (Scheme for payment of pension of civil pensioners of Rajasthan Government by Public Sector Banks).

1. The following shall be substituted in place of existing para 15 of appendix – VI of the above rules ,

“15. On receiving information regarding the death of the pensioner, the payment branch of bank shall obtain an application in Annexure-V for the payment of family pension along with the death certificate of the pensioner and commence the payment of pension at the rates mentioned by the Director, Pension in the disburser’s portion of Pension Payment Order. The payment branch of bank shall enter the date of death of the pensioner in register in Form on Appendix-III and in the disburser’s portion of Pension Payment Order . In case of any legal dispute the disburser’s portion maintained in the bank records shall be considered as the valid document.”

2. Existing para 15.3 of appendix – VI of the above scheme shall be removed.
