Applications in the prescribed proforma enclosed are invited from retired Supervisors / Asstt. Supervisors / Sr. Accountants / Accountants to work as consultant on short term contract basis for the post of Accountant in terms of in this office in terms of the Headquarters' Office Circular No.25-2025 issued vide letter No.1180-Staff(App.)-I/22-2016 dated 08.07.2025.

# The following broad terms and conditions are applicable to the contractual Officials: -

- Name of the Post: Accountant 1.
- Age should not be beyond 65 years as on 01.08.2025. 2.
- Retired person would be initially appointed for a period of 12 months, extendable up to a maximum 3. of five terms of 12 months each which is subject to performance and requirement of service.
- A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay 4. drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of contract. There will be no annual increment / percentage increase during the contract period. Further, an appropriate and fixed amount as Transport Allowance for the purpose of commuting between residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment.
- Paid Leave of absence may be allowed at the rate of 1.5 days for each completed month of service to 5. the retired Officer/official hired on short term contract basis. Accumulation of leave beyond a calendar year may not be allowed. However, absence during curfew, bandh, strike, lockdown shall be dealt with in a similar way as in the case of serving officers/officials.
- If retired Officials hired on short term contract basis remain absent, beyond paid leave in a month for 6. reasons other than those indicated above, his/her remuneration shall be deducted on pro-rata basis as

The engagement as Consultant will be purely on temporary basis, terminable at any time subject 7. to Administrative Convenience.

Statutory deductions levied by the Union / Government shall be made as per rules.
