CIRCULAR

Government servant belonging to any service or holding any post included in Group 'A' and Group 'B' shall submit an annual return regarding the **immovable property** inherited by him or owned or acquired by him or held by him on lease or mortgage either in his own name or in the name of any member of his family or in the name of any person in terms of *Rule 18 (1) (ii) of CCS (Conduct) Rules, 1964.*

However, Annual Property Return (Immovable) of officers/officials as per enclosed lists pertaining to the years 2016 to 2021 have not been received till date.

In view of above all the Officers/Officials who have not submitted their Annual Property Return (Immovable) for the above mentioned periods are requested to submit it by 30/06/2023. The officers/officials are also informed that as per DOPT's OM dated 21st December 2021, non-submission of IPR within the stipulated date might invite denial of vigilance clearance for empanelment, deputation and for applying to sensitive posts, assignments and training programs (except mandatory training).
