2. In terms of Para 5 of DOPT O.M. No. 36012/11/2016-Estt(Res-I)(Pt-II) dated 15.06.2018, the promotions shall be subject to further orders which may be passed by the Hon'ble Supreme Court.

3. The promotion is subject to the judgement dated 26.09.2018 of the Hon'ble Supreme Court in SLP(C) No. 30621/2011 and subject to further orders that may be passed by Hon'ble Supreme Court in the Jarnail Singh batch of cases, pending in the Supreme Court of India, as mentioned in DoPT's O.M. No 36012/16/2019-Estt.(Res.) dated 12.04.2022. Further, the promotion is subject to the conditions mentioned in Para-2 and Para-4 (a) & (b) in DoPT's O.M. No. 36012/16/2019-Estt (Res.) dated 12.04.2022.

4. The effectiveness of the date of 'Notional Promotion' shall be subject to the official(s) being present in the office on the date of their notional promotion.

5. All official(s) may exercise their option for fixation of pay as per provisions under CCS (RP) Rules, 1997, 2008 and 2016, as applicable and submit their option form to Administration Section within one month from the date of issuance of this order.

6. Following notional promotion, pay fixation and pension revision shall be carried out on a notional basis in accordance with the extant pay fixation rules and CCS (Pension) Rules, 1972. The actual increase in pay or pension will be as per para 4 of Circular No. 6 - Staff (Appt.III)/2025 dated 29.01.2025. No arrears shall be payable.

7. The Officers mentioned at Sl No. 01 to 48 (except Sl No. 01,02,08,15,33 & 39) and Sl No. 55 of the Panel Year 2014 will be redesignated as Senior Audit Officer w.e.f 20-11-2019, i.e. the date from which the post of Audit Officer was merged with that of Senior Audit Officer. Accordingly, the re-designated Senior Audit officers may exercise their option for fixation of pay in Pay Level 10 of Pay Matrix in terms of Headquarters' Office Circular No. 38-Staff Wing-2021 endorsed vide Letter No. 881/Staff (Entt.I)/122-2019 dated 27.10.2021.

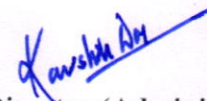
