It is submitted that a proposal for selection of agency for providing Security Services has been approved in principle vide orders of the competent authority as indicated at pre-pages.

- 2. Accordingly, this office had invited tender through Central Public Procurement Portal, as per the requirements specified in GFR under Open/Advertised Tender Enquiry Method vide Tender ID: 2019_CAG_509858_1 and Tender Ref. No. 360/GS/97-2019 dated 14.10.2019. Further, it is also submitted that the notice inviting tender was also published in the leading newspaper (dated 18.10.2019) besides publishing the complete tender document in the official website of this office.
- 3. Subsequently, the technical bids were opened on the schedule date and time by the Bid openers. The Technical committee evaluate all the bid received from 18 bidders. In this regard, it is submitted that the technical bid committee has qualified 5 bidders and disqualified 6 bidders out of 18 security agencies and remaining 7 bidders withheld due to shortfall of documents during technical evaluation vide their minutes.
- 4. In this connection, it is submitted that bids shall remain valid and open for acceptance for a period of 90 days from the last date of submission of Bids and the client may request for extension for another period of 30 days, without any modifications and without giving any reasons thereof. Meanwhile, Pandemic situation prevailing due to Novel Corona Virus (COVID-19) outbreak leading to an emergency like situation including the lockdown in the country and its anticipated adverse impact on the supply chain of necessary requirement.
- 5. In view of the given circumstances as detailed above, it is proposed that we may, if approved, scrap the existing tender enquiry and invite the tenders afresh through CPP Portal under open/advertised tender enquiry method. An advertisement to this effect is also proposed to be published in the leading English/Hindi Newspaper, besides publishing the tender enquiry on the official website of this office.
- 6. As the tenders are invited afresh, it is also proposed to extend the validity of the existing contract with the existing service provider (M/s A P SecuritasPvt. Ltd.) on the existing rates and terms and conditions till the finalization of the new tender process.

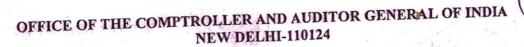
