

OFFICE MEMORANDUM

Sub: - PAYMENT OF DEARNESS ALLOWANCE TO THE STATE GOVERNMENT EMPLOYEES AT REVISED RATES EFFECTIVE FROM 01.07.2024.

The undersigned is directed to refer to this Department's O.M. of even number dated 4th July 2024 and to say that the Governor of Nagaland is pleased to enhance Dearness Allowance/Additional Dearness Allowance with effect from 01.07.2024 to the State Government employees at the following revised rates and subject to the following conditions:-

- (i) <u>Dearness Allowance for employees drawing pay under ROP Rules, 2017:</u> Increase of 3% w.e.f. 01.07.2024 from the existing rate of 50% to 53% of pay in the Pay Matrix.
- (ii) <u>Dearness Allowance for employees drawing pay under ROP Rules, 2010:</u>
 Increase of 7% w.e.f. 01.07.2024 from the existing rate of 239% to 246% of pay in the Pay Band including Grade Pay.
- (iii) Dearness Allowance for employees drawing pay under ROP Rules, 1999: Increase of 12% w.e.f. 01.07.2024 from the existing rate of 443% to 455% of pay including Dearness Pay.
- (iv) Additional Dearness Allowance for employees drawing pay under ROP Rules, 1993: Increase of 33% w.e.f. 01.07.2024 from the existing rate of 1353% to 1386% of pay
- The provisions contained in paras 1, 2, 3, 4, 7 & 9 of this Department's O.M. No. FIN/ROP/4/84/(Vol-I) dated 1st November, 2011 shall continue to be applicable while regulating Dearness Allowance/Additional Dearness Allowance under these orders.
- 3. The arrears from 01.07.2024 up to 31.10.2024 shall be credited to the respective GPF/CPF accounts of the employees concerned. Cash payment shall be made from 01.11.2024 salary onwards (that is, from the salaries of November, 2024). No part of the arrears up to 31.10.2024 shall be paid in cash except in case of those employees who have already retired from service or have died or are due to RETIRE ON SUPERANNUATION on or before 30.04.2025. The Government servants who have not yet opened Provident Fund Account can be allowed to draw the arrears only after the Provident Fund Accounts are opened so that the arrears can be credited to their Provident Fund Accounts. Arrears of DA/ADA may be paid in cash in respect of those employees who are not required to subscribe to Provident Fund under the Rules applicable to them which shall also include those employees who are covered under the National Pension System (NPS).
- 4. In respect of employees covered under National Pension System (NPS) 10% of DA Arrears is to be deducted and contributed to the NPS account. The remaining arrears may be paid in cash.
- 5. All heads of offices/DDOs are hereby instructed to carefully scrutinize all arrears DA/ADA bills to ensure that NO CASH PAYMENTS are allowed except in respect of those groups of employees as stated at para (2) & (3) above. All such bills must be certified to that effect by the head of office/DDO concerned. In the case of Government servants due to retire on superannuation, the exact date of retirement shall be recorded in each case. In the case of gazetted officers claiming cash payment on account of being due for retirement on superannuation, certificate to that effect indicating exact date of retirement shall be recorded on the body of the bill. The Treasury Officer shall personally ensure that no cash payment of arrears in respect of serving gazetted officers is allowed in the absence of such certificate.

6. The amount of arrears credited to the Provident Funds shall not be treated as accumulation for the purpose of temporary or Non-refundable withdrawals till 28.02.2026. While sanctioning temporary or Non-refundable withdrawals from Provident Funds, the sanctioning authority shall take care to **EXCLUDE** this lump sum credit till 28.02.2026. However, this condition shall not apply in case of final withdrawal from Provident Funds in respect of employees, who have retired, died or have ceased to be in service otherwise.





ORDER

Sub: Grant of Dearness Relief to State Government Pensioners.

The Governor is pleased to order that the existing rate of Dearness Relief sanctioned vide Finance Department Order of even number dated 14-03-2024 to the State Government Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extraordinary pension etc. shall be revised from 50% to 53% with effect from 01-07-2024.

For the purpose of this order

- Pension/Family Pension in the case of pre-01-01-2016 retirees and where Family Pension was sanctioned prior to 01-01-2016, means the Revised Pension or Revised Family Pension, as the case may be, effective from 01-01-2016 in terms of Finance Department Memorandum No. F.12(6)FD(Rules)/ 2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017 and F.12(6)FD(Rules)/ 2017 Pt.-I dated 06-06-2018.
- (ii) In the case of pensioners who retire from service on or after 01-01-2017 or where family pension is sanctioned for the first time on or after 01-01-2017, Pension/Family Pension means the Basic Pension/Basic Family Pension as the case may be in terms of Finance Department Notification No. F.12(6)FD(Rules)/ 2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017.
- —(iii) Dearness Relief will-also be admissible on the additional quantum of pension / family pension allowed to the pensioners who have attained the age of 80 years and above.
- (iv) Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- (v) Other provisions governing grant of dearness relief to pensioners' such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.
- (vi) This order shall also be applicable in case of Pensioners/Family Pensioners who are in receipt of provisional pension.

- This order shall not be applicable in case of Old Age Pensions, Political Pensions or any other kind of similar pensions, which are not related to the service rendered under Government
- (viii) Dearness Relief at revised rates as above would also be admissible to pensioners who retired/retire from service of Panchayat Samiti or Zila Parishad and whose Pension Payment Orders have been issued by the Director, Local Fund Audit Department or Director, Pension and-Pensioners' Welfare Department, Rajasthan, Jaipur.
- Cash payment shall be admissible-from 01-07-2024.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:

- 1. Short title and commencement. (1) These rules may be called the Rajasthan Civil Services (Pension) (Second Amendment) Rules, 2024:
- (2) They shall be deemed to have come into force with effect from 01-04-2024.
- 2. Substitution of rule 54B.- The existing rule 54B of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules, shall be substituted by the following, namely:
 - "54B. Additional Allowance to pensioners/family pensioners.- Allowance @5% of the basic pension/family pension on attaining the age of 70 years and @10% of the basic pension/family pension on attaining the age of 75 years to the pensioners/ family pensioners, as the case may be, shall be given. This allowance shall be given to pensioners/family pensioners upto the age of 80 years and no dearness relief shall be payable on such allowance."
 - 3. Amendment of rule 67.- In rule 67 of the said rules,-
 - (i) for the existing expression—"disabled", wherever occurring, the expression "specially abled" shall be substituted;
 - (ii) after the existing clause (e) and before the existing proviso, the following new clause (f) shall be inserted, namely:-
 - "(f) Specially abled siblings only in case where a deceased Government servant or pensioner is not survived by a widow or widower or a child or parents engible for family pension;";and
 - (iii) after the existing proviso and before the existing explanation, the following new proviso shall be inserted, namely:-

"Provided further that the family pension to specialy abled sibling shall be payable if the disability existed before the death of the Government servant or pensioner. The other conditions as applicable for the son/daughter of Government servant/pensioner who is suffering from any disorder or disability of mind or is physically crippled or specially abled or blind or deaf and dumb shall be the same as provided in these rules."

- 4. Amendment of rule 87.— In rule 87 of the said rules, after the existing subrule (7), the following new sub-rule (8) shall be added, namely:-
 - "(8) The Pension sanctioning authority shall indicate in the pension payment order the name of the Government servant's spouse, if alive, as family pensioner and shall also indicate in the pension payment order the names of the permanently specially abled child or children, dependent parents and specially abled siblings as family pensioners, if there is no other member of family to whom family pension may become payable."

Government hereby order revision of the Dearness Relief (DR) sanctioned in the Government Order 8th read above to the Pensioners of Government of Telangana from 22.75% of basic pension to 26.39% of basic pension, from 1st of July, 2022.

- 2. The above revision of Dearness Relief shall be applicable to;
 - a) The employees who retired from service on or after 01.07.2018 and are drawing pension as per the Revised Pay Scales, 2020
 - b) The employees who retired before 01.07.2018 and whose pension was consolidated as per Government Orders issued vide reference 5th read above.

- 3. Government also hereby order revision of the Dearness Relief to the State Government Pensioners, who are drawing pension in the Revised Pay Scales, 2015 from 59.196% to 63.912% of the basic pension from 1st of July, 2022.
- 4. Government hereby order revision of Dearness Relief from 34% to 38% of basic Pension from 1st July, 2022 in respect of the Pensioners who retired while drawing UGC/AICTE Pay Scales, 2016.
- 5. Government also hereby order revision of Dearness Relief from 203% to 212% of basic Pension from 1st July, 2022, in respect of the Pensioners who retired while drawing UGC/AICTE Pay Scales, 2006 and whose pension was not consolidated as per UGC Pay Scales, 2016.
- 6. These orders shall be applicable to;
 - a) All State Government Pensioners in receipt of Service Pensions, Family Pensions under Revised Pension Rules, 1951, Telangana (Andhra Pradesh) Liberalised Pension Rules, 1961, Telangana (Andhra Pradesh) Government Servants (Family Pension) Rules, 1964 and Revised Pension Rules, 1980.
 - b) Teaching and Non-Teaching pensioners of Municipalities, Panchayat Raj Institutions and Aided Educational Institutions, in receipt of pensions under the Telangana (Andhra Pradesh) Liberalised Pension Rules, 1961 and Telangana (Andhra Pradesh) Government Servants (Family Pension) Rules, 1964.
 - c) Teaching and Non-Teaching staff in Aided Educational Institutions in receipt of pensions under the Contributory Provident Fund-cumpension and Gratuity Rules, 1961 and Telangana (Andhra Pradesh) Liberalised Pension Rules, 1961.
 - d) Those drawing family pensions as per Government Orders issued vide references 1st & 5th read above.

- e) Pensioners in receipt of compassionate pension under the rules for Compassionate Pensions and Gratuities in the Hyderabad Civil Services Rules.
- f) Pensioners who were in receipt of Pensions under the Wound and the Extraordinary Pension Rules.
- g) Jagir and Estate Pensioners and
- h) Pensioners governed by the Telangana Revised Pension Rules, 1980.
- 7. These orders shall not be applicable to Financial Assistance Grantees and others who are not entitled for Dearness Relief.
- 8. The amount of Dearness Relief shall be rounded off to the next rupee.
- 9. The Revised Dearness Relief shall be paid along with the pension of November, 2024 payable in the month of December, 2024. However, the arrears of revised Dearness Relief to the pensioners from 01.07.2022 to 31.10.2024 shall be paid in seventeen (17) equal installments from the month of January, 2025.
- 10. All the Treasury Officers/Pension Payment Officers shall workout and make payments of the Dearness Relief on Pension sanctioned in this order without waiting for further authorization/instructions from the Accountant General(A&E), Telangana and Andhra Pradesh, Hyderabad, in terms of the orders issued in the G.O.Ms.No.270, Finance & Planning (FW:PSC.I) Department dt.07.10.1986.
