

In partial modification of this office circular No.259/Vol-II/50 dated 07/06/2024, it is stated that Govt. of West Bengal, School Education Department, Planning & Budget Branch in their MemoNo.340-SED-18099/40/2020-PB SEC-Dept.of SE dated 20/06/2024 have modified the date of effect for payment of dearness relief with effect from 1/4/2024 instead of 1/5/2024 as was sanctioned under Memo. No. 166-SED-18099/40/2020-PB SEC-Dept. of SE dated 11/03/2024 for the pensioners /family pensioners of Government Aided Educational Institutions who are drawing pension/family pension at revised rates of pension on the basis Of Memo No.52/ES/P/P&B/10M-99/2019 dated 14/02/2020, circulated by this office vide No. Pen.Co ordn/259 Vol-II/210 dated 27/04/2020.

This office is in receipt of some queries from few Pension Disbursing Authorities, pensioners, Pension Sanctioning Authorities etc. in respect of certain categories of pensioners (viz. retired Nonteaching staff of Non-Govt. College, retired employees of Non-Govt. Educational Institution , retired Ex-management staff of North Bengal Medical College and Burdwan Medical College) regarding continuation of Interim Relief beyond 31/12/2018.

In this connection, it is stated that Interim Relief @8% with effect from 1/7/2016 was introduced on the basis of Finance Department, Pension Branch Memo No.224-F(Pen) dated 3/6/2016 circulated under this office Circular No. Pen.Co-ordn/93/Vol-VI/204 Vol-II/111 Vol-VII/259 Vol-II/217 Vol-II/258 Vol-II/213 dated 27/6/16 and discontinued with effect from 1/1/2019 under Memo No.353-F(Pen) dated 06/07/2018 circulated under circular No.Pen.Co-ordn./93/Vol-VI/159 dated 13/11/2018.

All Pension Disbursing Officer are, therefore, requested to review the matter and in case any overpayment has been occurred due to allowing Interim Relief beyond 31/12/2018, necessary arrangement to adjust the said amount may be made.

Subject:- Grant of dearness relief on pension/family pension to the pensioners/ family pensioners (teaching & non-teaching) of State Aided Non Govt. Colleges w.e.f. 1/04/2024 instead of 1/5/2024

In partial modification to this office circular No.s Pen.Co-ordn./51/Vol-VIII/204/Vol-II/49 dated 03/06/2024, it is stated that the Govt. of West Bengal, Department of Higher Education Department, in their Memo no. 605-Edn(U) dated 18/06/2024 have modified the date of effect for payment of dearness relief with effect from 1/4/2024 instead of 1/5/2024 as sanctioned under Memo. No. 235-Edn(U) dated 6/3/2024 for the pensioners /family pensioners of State aided as well as Government Aided Educational Institutions .

Accordingly, all concerned Pension Disbursing Officers are, therefore, requested to allow dearness relief @ 14% on revised rates of pension/family pension and @161% on un-revised rates of pension/family pension with effect from 01/04/2024 instead of 01/05/2024 to the above categories of pensioners/family pensioners.

Other terms and conditions prescribed in the circular dated 03/06/2024 ibid will remain unchanged.
