

Subject: - Revision of Rate of Dearness Relief to State Govt. Pensioners/family pensioners w.e.f. 01-07-2025.

In pursuance to the Government of India OM No.42/02/2024-P&PW(D) dated 08/10/2025 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR) payable to State Government Pensioners/Family Pensioners shall be enhanced by 3% from the existing rate 55% to 58% of the basic Pension with effect from 1<sup>st</sup> July '2025. The DR arrears for the period from 1<sup>st</sup> July,2025 to 30<sup>th</sup> September,2025 shall be paid in cash/credited to the pensioners'account.
