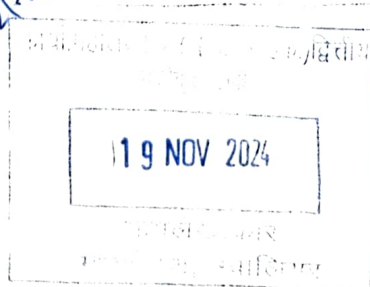

Subject: - Revision of Rate of Dearness Relief to State Govt. Pensioners/Family pensioners w.e.f 01-07-2024.

In pursuance to the Govt. of India, Announcement dated 16/10/2024 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR) payable to State Government Pensioners/Family Pensioners shall be enhanced by 3% from the existing rate 50% to 53% of the basic Pension with effect from 1<sup>st</sup> July '2024. The DR arrears for the period from 1<sup>st</sup> July '2024 to 31<sup>st</sup> October '2024 shall be paid in cash./credited to the pensioner's account.

This is issued with the approval of the Competent Authority.


