

In pursuance to the Govt. of India, Ministry of Personnel, Public Grievances & Pensions OM No.42/7/2021P&PW(D)e-7330 dated 27/10/2021 (copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR)payable to State Government Pensioners/Family Pensioners shall be enhanced by 3% from the existing rate of 28% to 31% with effect from 1" July, 2021.
