In pursuance to the Govt. of India, Ministry of Personnel, Public Grievances & Pensions'OM No.42/07/2021-P&PW(D) Dated: 22nd July'2021 (copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR)payable to State Government Pensioners/Family Pensioners shall be increased by 11% 17% to 28% with effect from 1st July, 2021 RPT from 1st from the existing rate of July 2021..
