

(ROP) Rules, 2017 shall be admissible as per rate shown below:

Period from which payable	Rate of D.A./D.R. enhanced	Rate of D.A./D.R. per mensem
From 01/01/2024	4%	50% of Basic Pay/Basic Pension

Note :- The payment on account of D.A./D.R. involving fractions of 50 paise and above may be rounded off to the next higher rupee and fraction of less than 50 paise may be ignored.

- 1) The order shall apply to Government employees who are brought over to the revised scale of pay w.e.f. 01/04/2016 and to those who elected to retain the scale of pay that prevailed prior to 01/04/2016. In case of the former, pay for the purpose of D.A. will be as defined in F.R. 9(21) (a) (i) including stagnation increment.
