Subject: CAG's 101 Innovation Ideas Initiative – encouraging innovation and participation across IA&AD – reg.

Madam/Sir,

As you are aware, CAG's 101 Innovation Ideas Initiative is being implemented as a flagship internal initiative of IA&AD to encourage innovative ideas, solutions, products, practices and process improvements from offices/formations across SAI India.

2. The concept paper and submission form for the initiative have already been circulated vide PPG Wing mail dated 18 June 2026. The detailed concept, eligibility, thematic areas, evaluation framework and submission requirements may kindly be seen therein.
3. The timelines relating to launch and submission stage, as per the concept paper, are as under:

Phase	Timeline
Launch of Initiative and Portal Rollout	30 June – 15 July 2026
Submission Stage	16 July – 12 August 2026

4. The dedicated website/portal for submission of entries is expected to be activated shortly. In the meantime, offices may kindly encourage interested officers and staff to identify innovative ideas and keep their entries ready in the prescribed submission format, so that the same may be uploaded once the portal is made available.

5. All field offices are requested to kindly make focused efforts to encourage innovation and maximum participation from officers and staff of IA&AD. In this

regard a copy of the presentation detailing the roadmap for outreach is enclosed. This contains aspects relevant to CAG office (PPG Wing) as well as Functional Wings of CAGs offices/Field Offices. All Functional Wings/ Field Audit offices to use this as a guidance. any other ideas may be shared with sao5ppg@cag.gov.in

6. In this regard, a meeting shall be convened by the C&AG next week, wherein all the Heads of Department of field offices shall participate virtually. The detailed schedule of the meeting and link for joining the meeting shall be shared in due course. The steps taken for outreach are expected to be shared at the meeting.
